
What is Disability?

"Disability" is defined by the Americans with Disabilities Act (ADA) as a physical or mental impairment that substantially limits one or more major life activities, a record of such an impairment, or being regarded as having such an impairment

"Invisible" Disabilities Include...

- Learning Disabilities
- Epilepsy
- Hearing Impairments
- Vision Impairments
- Intellectual Disabilities
- Psychiatric Disabilities
- Chronic Illnesses (Heart Disease, Cancer, Diabetes, etc.)

The Illiteracy-Disability Connection

 Approximately 40% of illiterate adults in the US have one or more disabilities

 Roughly 90% of students with multiple disabilities never acquire functional literacy skills

Disability, Poverty's Invisible Twin

 The poorer the community the greater the percentage of people with disabilities

• In Mississippi, the poorest state, 38% of the citizens are people with disabilities

The Help America Vote Act

- Requires People with Disabilities be able to vote privately and independently ... in the same time and manner as other voters
- One accessible voting device in every polling place
- Appropriated \$750 million for to buy accessible machines
- Requires a 10% state match in funds

Voter Participation by Type of Disability

	Percent voting	Number who voted in mill.
Overall	63.6%	131.1
People without disabilities	64.5%	116.4
People with disabilities	57.3%	14.7
Hearing impairment	63.1%	4.3
Visual impairment	56.8%	2.2
Mental or cognitive impairment	46.1%	3.5
Difficulty walking or climbing stairs	56.8%	8.8
Difficulty dressing or bathing	46.4%	2.0
Difficulty going outside alone	45.7%	4.0
