## Office of the General Secretariat of the Organization of American States in Jamaica (GS/OAS – Jamaica)

“The Organization of American States is the hemispheric political forum inclusive of all the countries of the Americas, committed to the strengthening of democracy, the promotion and protection of human rights, the advancement of integral development and the fostering of multidimensional security, all equal and interdependent, with justice and social inclusion, for the benefit of the peoples of the Americas.” (AG/RES. 2814 (XLIV-O/14))

The OAS Offices in member states were created to serve as centers to promote and coordinate the activities of the OAS General Secretariat in member states. The Offices and their staff are therefore an integral part of the OAS General Secretariat. They allow the Organization to effectively execute its projects and programs, obtain reliable and timely information on the political and economic developments of the member states and ensure direct, on the ground engagement with member states and their citizens. The main role of the OAS Office in Jamaica is thus to bring the work of the OAS, including the opportunities offered, closer to the people of Jamaica.

Jamaica has been a member of the OAS since 1969. The Office of the General Secretariat of the Organization of American States in Jamaica was established on March 12, 1971. Since its inception in 1971, the Office of the General Secretariat of the Organization of American States (GS/OAS) in Jamaica has supported the OAS General Secretariat in achieving its mission, mandates and to strengthen its four pillars- democracy, human rights, integral development, and multidimensional security.

The Office of the GS/OAS in Jamaica has an active role in maintaining an institutional presence for the OAS in Jamaica,

promoting the activities of the organs of the General Secretariat, collaborating with the Government, private sector, and civil society organizations in Jamaica, as well as specialized organizations and other entities, to implement OAS policies, programs and activities based on Jamaica’s development needs and the OAS Strategic Plan for Partnerships for Integral Development. In particular, the Office collaborates with other Inter-American institutions, international and regional partners to increase development partnerships and forge synergies on thematic areas in accordance with the four main pillars of the OAS.

The COVID-19 pandemic has forced us to think out of the box and address both new challenges that were brought on by this pandemic and existing challenges that have been exacerbated. The new reality of increased virtual events has created more opportunities to enhance the visibility of the work of the OAS and for more collaboration with partners and within the GS/OAS.

The GS/OAS Office in Jamaica will continue to support the mutually beneficial partnership between the OAS and the Government of Jamaica and to serve as the liaison between the Secretary General, the various OAS Secretariats and Departments and the Government of Jamaica to ensure the successful implementation of OAS activities with Jamaica.



The OAS projects website provides a summary of the main programs, activities, and initiatives that the General Secretariat of the Organization of American States (GS/OAS) is developing, implementing, and supporting with Member States, as the GS/OAS promotes and strengthens democracy, human rights, multidimensional security, and integral development. The GS/OAS successfully executes its work through its various Secretariats and Offices at Headquarters and in Member States.

The OAS Office in Jamaica provides support and ensures the proper implementation of the mission, mandates, and pillars of the OAS. ## Office of the GS/OAS in Jamaica


### February 2022

The Office of the GS/OAS in Jamaica organized a **virtual meeting between the OAS** Representatives in Jamaica, the Bahamas and St. Lucia and the UN Coordinator and several Heads of UN agencies in Jamaica (with responsibility for the Bahamas, Bermuda, Cayman Islands and Turks and Caicos) and in Washington, D.C. to explore possible collaboration between the Offices of the OAS and the UN in the Caribbean. A follow up meeting with other regional UN Coordinators and OAS officials at Headquarters was proposed to explore the areas of cooperation that were identified.

### March 2022

The Office of the GS/OAS in Jamaica in collaboration with the Faculties of Social Science (FSS) and Humanities of the

University of the West Indies (UWI), Mona Campus organized the **2022 OAS Art and Poetry Competition** in celebration of the 2022 Inter American Week for People of African Descent. Twenty-two artists and poets submitted their original works of art and poetry. The virtual event for the finalists to present their works of art and poetry and for judges to select the winners of the competition was held on March 23, 2022. A panel of judges from the UWI and the Edna Manley College of the Visual and Performing Arts selected the top three candidates in both categories of art and poetry. The event included a presentation by Mr. Vivian Crawford, Executive Director of the Institute of Jamaica, titled “Stories of Courage in the Americas: Resistance to Slavery and Unity against Racism.” The live virtual event was watched by 139 viewers. JN Bank and Digicel offered money prizes and tablets to the three winners in each respective category of art and poetry. The handover ceremony of prizes was held at the GS/OAS Office in Jamaica on March 25. #### IV Extraordinary Meeting of the Inter American Network of High-Level Authorities on Policies for Afrodescendant Populations.

The Office of the GS/OAS in Jamaica collaborated with the OAS Department of Social Inclusion (DSI) to explore the possibility of hosting a joint event on the issue of reparation (after the topic was discussed during the first Chat with the OAS in April 2021). In March 2022, DSI organized a panel discussion on the topic of “reparation in the Americas”,

which was held during the RIAFRO meeting, and was moderated by the OAS Representative in Jamaica. The panelists included Pastor Murillo, Member of the UN Permanent Forum for People of African Descent, Dr. Ron Daniels, Convener, National African American Reparations Commission, Emmanuela Douyon, Executive Director, Policit e and (Professor Sir Hillary Beckles, Chairman, CARICOM Reparations Commission, who was ultimately not able to participate).



#### August 2022

#### “A Chat with the OAS” in observance of the Fifth Inter-American Week for Indigenous Peoples.

The Office of the GS/OAS in Jamaica provided support with the organization of this Chat and invited Dr. Amina Blackwood Meeks, Orator & Lecturer of Caribbean Culture, and Identity in Jamaica, to make a presentation during the Chat. The focus of the Chat was, ‘The Role of Indigenous Women in the Preservation and Transmission of Traditional Knowledge in the Americas’, which was also the theme of the Inter American Week. 75 viewers watched the live discussion.

#### September 2022

#### The Office of the GS/OAS in Jamaica organized “A Chat with the OAS” in commemoration of Jamaica’s 60th year of independence.

Dr. Wayne Henry, Director General of the Planning Institute of Jamaica (PIOJ) in dialogue with OAS Assistant Secretary General Nestor Mendez, discussed Jamaica’s journey as an independent nation, Jamaica’s vision 2030, which aims to empower Jamaicans, to create a stable society, a prosperous economy, and a healthy environment, as well as the feasibility of reaching the main goals of Vision 2030 in the post-COVID-19 pandemic era. 67 viewers watched the live event.

## Projects in the Pipeline for 2023 and Beyond

Title: National Training Seminar on the Detection and Identification of Synthetic Drugs, including New Psychoactive Substances (NPS) and their Precursor Chemicals, Kingston, Jamaica

- Duration: One week
- Objective: To strengthen the capacity of officers from counterdrug law enforcement and other agencies with competence in the subject matter to detect and investigate synthetic drugs, NPS, and to effectively control precursor chemicals.
- Expected Outcome: Strengthened capacity to detect and investigate synthetic drugs and NPS production and trafficking, and to effectively control precursor chemicals used in their illicit manufacture.



- Budget: US\$20,000
- Title: Regional Training Course on the Control of Illicit Drug Trafficking for Female Officers, in CCITS Headquarters in Port of Spain, Trinidad and Tobago
- Duration: One week.
- Objective: Increase the capacity of female drug and chemical control officers of participating OAS Caribbean member states in the investigation of illicit drug trafficking. This course provides participants with the opportunity to be equipped with the latest investigative techniques and procedures specific to controlling illicit drug trafficking.
- Expected Outcome: Increased knowledge and skills of female drug and chemical control officers on the techniques and tools for the identification, analysis, and control of illicit drug trafficking.
- Total budget: US\$ 5,000 for Jamaica's participation.

Title: [Regional Course on Drug Investigations, in Bridgetown, Barbados](#)

- Duration: One week
- Objective: Enhance the capacity of drug control investigators on specialized techniques related to the development and analysis of strategic, operational, and prospective intelligence to investigate drug trafficking networks operating in the Americas.
- Expected Outcome: Increased knowledge and skills of drug control officers to detect and investigate illicit drug trafficking.
- Project budget: US\$ 5,000 for Jamaica's participation

Title: [Meeting of CICAD's Working Group on Aerial Drug Trafficking Control, Bridgetown, Barbados](#)

- Duration: Three days

- Objective: To strengthen operational capacity of competent authorities to investigate, detect, and interdict aerial drug trafficking, as well as to enhance inter-agency cooperation at the national and regional level.
- Expected Outcome: Strengthened operational capacity of competent authorities to investigate, detect, and interdict aerial drug trafficking, and enhanced inter-agency cooperation at the national and regional level.
- Project budget: US\$3,000 for Jamaica's participation.

Title: [Meeting of CICAD's Group of Experts on Chemical Substances and Pharmaceutical Products, Quito, Ecuador](#)

- Duration: Three days
- Objective: To facilitate information exchange and best practices to counter the proliferation of synthetic drugs, including through public/private postal and parcel services and to increase access to controlled substances for medical and scientific purposes, while preventing their diversion to illicit purposes.
- Expected Outcome: Strengthen the capacities of Jamaica's drug control agencies to counter the illicit use of precursor chemicals in the production and manufacture of natural and synthetic drugs, including NPS.
- Project budget: US\$3,000 for Jamaica's participation.

Title: [Meeting of CICAD's Group of Experts on Maritime Narcotrafficking, San Salvador, El Salvador](#)

- Duration: Three days
- Objective: To strengthen operational capacity of maritime authorities, law enforcement, and customs agencies to investigate, detect, and interdict drug



trafficking in the maritime, riverine, and port domains, as well as to enhance inter-agency, regional and international cooperation in maritime counterdrug multilateral operations.

- Expected Outcome: Strengthen the capacities of Jamaica’s law enforcement, port authorities, customs, and other agencies to investigate, detect, and interdict drug trafficking in the maritime, riverine, and port domains.
- Project budget: US\$ 3,000 for Jamaica’s participation
- Main challenges: Jamaica did not participate in the last in-person meeting of CICAD’s Group of Experts on Maritime Narcotrafficking, which took place in Lima, Peru in September 2022. It is important to have Jamaica participate at the next meeting of the Group, which will take place in September 2023 and will be chaired by El Salvador.

- Location of project implementation: Virtual with the participation of OAS member states
- Project objectives: Measure progress in implementing the OAS Hemispheric Plan of Action on Drugs 2021-2025
- Project description: The MEM, mandated by the 1998 Summit of the Americas, is a peer review process that measures the progress of actions taken by OAS member states to address the drug problem and related crimes. The MEM evaluates member states’ implementation of the Hemispheric Plan of Action on Drugs 2021-2025, which is aligned with the UNGASS 2016 goals and objectives and the United Nations 2030 Sustainable Development goals. The only multilateral evaluation of its kind in the world, the MEM highlights strengths and weaknesses in its national reports and encourages national dialogue among policymakers. Additionally, the ES-CICAD publishes thematic annual hemispheric briefs based on the findings of the MEM national evaluation reports.
- Project duration (Start date/End date): 8th round spans from 2021-2024
- Total Budget allocation (in case of regional projects, please specify allocation for component in Jamaica): US\$910,995 (total project budget for 2022 at ES-CICAD. No allocation to member states.)

## Multilateral Evaluation Mechanism (MEM)

- Project name: Multilateral Evaluation Mechanism (MEM) – 8th round – Area of Measures to Control and Counter the Illicit Cultivation, Production, Trafficking, and Distribution of Drugs, and to Address their Causes and Consequences – 2022

## Project Status

- Status of implementation (Started/ on target/not on target; Outputs and activities achieved): Ongoing. Throughout 2022 Jamaica participated in the MEM eighth evaluation process through two MEM sub-bodies. First, the MEM National Coordinating Entity (NCE) for Jamaica through its Ministry of National Security provided updated information for the MEM's eighth round Jamaica report on the drug supply reduction area of 'Measures to Control and Counter the Illicit Cultivation, Production, Trafficking, and Distribution of Drugs, and to Address their Causes and Consequences.' All national thematic reports underwent a thorough evaluation by the MEM Governmental Expert Group (GEG) from early 2022 through October 2022. Senior Superintendent Jervis Moore, and Detective Sergeant Jermaine Folks, GEG experts for Jamaica, participated in the GEG's virtual plenary drafting meetings, during which experts do not participate in the evaluation of their own country. The GEG concluded 32 final draft national evaluation thematic reports which were approved at the 72nd CICAD regular session in November and published in December.
- Main challenges: Ensure participation of NCEs and GEG experts throughout the evaluation year.

## Project Sustainability

- Plans for institutionalization of project, including funding, staffing and institutional support: Partially funded by the OAS Regular Fund and Indirect Cost Recovery (ICR), and continuing to seek specific funding from member states.
- Foreseeable risks and gaps to address for successful project completion: None.
- Existing complementary projects and opportunities in Jamaica: Given that the national evaluation reports signal both strengths and challenges, these reports

highlight areas requiring training or other assistance in drug control.

## Projects in the Pipeline for 2023 and beyond

- Title: MEM 8th evaluation round - Areas of Institutional Strengthening; Research, Information, Monitoring, and Evaluation; and International Cooperation – 2023.
- Duration: One year.
- Objective: Measure progress in implementing the OAS Hemispheric Plan of Action on Drugs 2021-2025 in the evaluated areas.
- Expected Outcome: National evaluation thematic reports 2023.
- Project budget: US\$ 910,995 (total project budget for 2023 at the CICAD Executive Secretariat. No allocation to member states.)

## Inter-American Observatory on Drugs (OID)

- Location of project implementation: The project consists mainly of training and sensitization and most were virtual events.



- Concrete benefits for Jamaica: Capacity building for local authorities on how to develop and implement early warning systems (EWS) on drugs and drug information networks (DINs) will be the main benefit for Jamaica. EWS are useful tools that allow countries to detect, identify, and respond to the threats posed by emerging substances including new psychoactive substances (NPS). This is particularly important for Jamaica given the recent apparent increase in the availability and use of a substance referred to as ‘molly.’ The use of the substance appears to be increasingly prevalent among youth, and an early warning system is the perfect tool for dealing with these types of emerging substances.
- Provide technical support to member states’ EWS and DINs.

- Project description: The project aims to build capacity through training events and workshops, collecting and disseminating information on emerging drug threats through the Early Warning system in the Americas (known by its Spanish-language acronym, SATA) webpage, and providing technical support directly to member states as they develop or improve their EWS and DINs.
- Project duration: March 2020 to December 2023.
- Total Budget allocation: No specific allocation for Jamaica.
- Disbursement in Jamaica to date: The project does not contemplate direct disbursements to Jamaica, but a participant from Jamaica was sponsored by this project to attend an in-person training event in Port of Spain Trinidad and Tobago, in December 2022. The total cost of Jamaica’s participation was US\$2,526.

## Project objectives

- Share and disseminate information and early warning alerts on NPS, opioids, and other emerging drug threats.
- Produce reports that describe the situation in member states, including how they are affecting men, women, and children in different ways.
- Build capacity among law enforcement, laboratory, public health, drug treatment, and drug observatory personnel on how to develop and implement a local EWS, as well as drug information networks (DINs).
- Develop manuals and standardized protocols to guide member states.
- Develop standards, criteria, and instruments for EWS and update existing instruments for DINs.
- Create a forum for on-going operational and policy level discussions and sensitization on NPS, opioids, and other emerging drug threats.
- Collaborate with other international agencies and partners working on emerging drug issues.

## Project Status

- Outcomes / Achievements: Jamaica is the only country in the Caribbean that received both trainings (ATI and CCM) between 2018 and 2020. In 2021 and 2022, through the COVID pandemic, ES-CICAD continued to communicate with the judiciary and the international partners and stands ready to provide virtual technical assistance for the ATI and CCM programs, in accordance with Jamaica’s interest and priorities. In May 2022, ES-CICAD invited Jamaica to present at the ISSUP (International Society of Substance Use Prevention Professionals) International Conference, held in Abu Dhabi and organized by ISSUP. Judge Jacqueline Wilcott presented the highlights of the ATI system in Jamaica in Sub-plenary 5, it was titled “Alternative

to Incarceration System: Treatment Interventions for Persons with Substance Use Disorders Who are in Contact with the Criminal Justice System” on Friday May 13, 2022. In July 2022 a delegation from ES-CICAD visited Jamaica and discussed technical assistance needs and interest for both ATI and CCM for future activities and projects.

- Benefits for Jamaica: Professionals trained from various institutions (including judicial officers, as well as Parish Judges, the Children’s Drug Court, Department of Correctional Services, Ministry of Health, the Jamaica Constabulary Force, (JCF), the National Council on Drug Abuse (NCDA), and potential expansion to other ATI programs, including the CCM model.
- Risks/Challenges: In 2021 and 2022 there were delays in program implementation due to the unexpected circumstances related to the COVID pandemic. Nevertheless, ES-CICAD continued to communicate with the judiciary and the international partners to explore Jamaica’s interest and priorities on ATI and CCM in upcoming years.

## Project Status

- Outcomes / Achievements: Since 2021, ES-CICAD invited Jamaica to participate in different activities to support member states in the development and implementation of national drug policies, in alignment with the new CICAD/OAS Hemispheric Strategy on Drugs (2020) and its Plan of Action (2021–2025). These activities consisted of trainings, technical and policy discussions, direct technical assistance for the drafting of Jamaica’s national drug policy, strategies, and action plan, as well as the creation of a monitoring and evaluation framework. As part of this process, ES-CICAD held a virtual meeting in November 2021, to discuss a work plan for 2022. This was followed by a three-day virtual training on drafting a National Drug Policy for English-speaking member states at which Jamaica participated. Following this event, a dedicated workshop on Monitoring and Evaluation was hosted in Kingston, Jamaica, for representatives from English-speaking Caribbean countries. The opening ceremony was addressed by several officials and the feature address was delivered by the Minister of National Security who is also the Deputy Prime Minister. On the margins

of the meeting, a discussion was held with representatives from different stakeholders, both government and non-government, to discuss the development of the national drug policy.

- Subsequently, Jamaican stakeholders met and formed a technical working group to plan the development of the national policy. Following the first meeting, the working group agreed to approach ES-CICAD for the engagement of a consultant to assist with the drafting of the Policy. This was completed in November 2022 and work continues on this project.
- Benefits for Jamaica: This initiative will support Jamaica with the development of its national drug policy and plan of action.
- Risks/Challenges: The improvement of the COVID-19 situation allowed the project to undertake in-person meetings including the Monitoring and Evaluation Workshop convened in Jamaica in June 2022.

## Project Status

- Status: Ongoing (editing report)
- Outcomes / Achievements: In 2022, ES-CICAD concluded a series of diagnostic studies in Argentina, Colombia, Costa Rica, the Dominican Republic, and Jamaica, which sought to better understand how sensitive the criminal justice system is to gender when offering alternatives to incarceration for low-level, drug-related offenses. The studies generated gender-disaggregated baseline data to assist drug authorities in improving their ability to track and report sentencing outcomes. This type of data is expected to contribute to the development of effective drug policies and programs that are gender-sensitive and address the drug problem without contributing to gender inequality. They will also inform and support the design of appropriate interventions or adjustments to current alternatives to incarceration for these populations.
- Benefits for Jamaica: A draft final report of the diagnostic study was submitted to Jamaica in April 2022, following conclusion of the data collection in October 2021. Feedback is being incorporated by ES-CICAD in the final version of the report, which will then be disseminated to Jamaican stakeholders. In addition, as part of the project, eighteen representatives from Jamaica participated in the "Training Series on Gender in the Criminal Justice System: Alternatives to Incarceration for Drug-Related Offenses," held from May 26 to August 4, 2021. This training series was offered to professionals in the criminal

justice, health and social integration systems of the countries that are participating in the project. Its objective was to foster a deeper understanding of the gender dimensions of drug-related offenses amongst participants, and to strengthen their skills in the design and implementation of alternatives to incarceration policies and/or programs from a gender perspective. A second phase of this project is currently being explored, which would start in 2023.

- Risks/Challenges: The emergency due to COVID-19 delayed the start of the diagnostic study due to the closure of the courts, which led to an extension of the project. However, ES-CICAD was able to successfully conclude the project in 2022.

## Project Status

- Status: Ongoing
- Outcomes / Achievements: From February to May 2021, an analysis of existing resources and gaps for the monitoring and evaluation (M&E) of the Jamaica Drug Treatment Court (DTC) program was completed; the report was validated by the Jamaican designated points of contact in October 2021. Eleven judicial and government officials involved in the operation, monitoring and evaluation of the DTC program in Jamaica successfully completed the online course “Good Practices for the Monitoring and Evaluation of Drug Treatment Courts” (May 4-June 1, 2021). All the participants who responded to the pre- and post-training survey reported an improvement in their knowledge and/or in specific abilities for DTC M&E. A draft action plan to strengthen DTC monitoring and evaluation mechanisms was developed by Jamaica. On September 23, 2021, the ES-CICAD project team held a meeting with the points of contact in the Judiciary

and NCDA to discuss and define technical assistance activities for the remainder of the project.

- In 2022, the team continued to engage the Jamaican DTC team on two major activities. As part of their area of interest was participation in the DTC Cost Study that is a component of this project. The Pontifical Catholic University of Chile (PUC) was the identified organization to undertake this process in Jamaica and six other OAS member states. In August, a mission to Jamaica was conducted by the PUC research team, accompanied by an ES-CICAD consultant, to interview a number of stakeholders who contribute to the operations of the DTC in Jamaica and collect data to assess the costs associated with the operations of these courts. The data collected is now being analyzed and a draft report will be submitted to Jamaica for review in early 2023. Additionally, a session was convened with a DTC M&E expert from the National Association of Drug Court Professionals and representatives from the Judiciary, the National Council on Drug Abuse, and other stakeholders of the DTC, to develop a logic model and indicators to support the monitoring and evaluation process of the DTC in Jamaica. A draft document will be shared with the Jamaican DTC stakeholders early in 2023. A follow-up training will be held in February 2023 to further consolidate the skills and knowledge acquired by the DTC team in monitoring and evaluation.
- Benefits for Jamaica: Strengthening of DTC M&E mechanisms and evidence-based DTC practices, and access to cost data to inform decision-making regarding the DTCs.
- Risks/Challenges: Some of the project activities have been delayed due to the COVID-19 pandemic, but the project moved forward and is due to close in 2023.

- CICTE will carry out a technical assessment and engagement mission in Jamaica during 2023 and meet with national authorities to define needs for customs and border security operations, with particular focus on the security and inspection of cargo and conveyance in marine ports of entry.

## Cybersecurity

- CICTE supported Jamaica's efforts to update its National Cybersecurity Strategy during 2022.
- Supporting the Cyber Awareness month and as part of our continued support to JA-CIRT to raise national awareness of cyber risks and share safe online practices, CICTE participated in the webinar entitled: "Internet Governance in a Data Protected World," in November 2021 and collaborated with JA-CIRT in 2022 by coordinating with AWS as an expert speaker during their webinar series.
- "Threat Defense Challenge", which was organized by OAS / CICTE in 2020, with the support of JaCIRT, the Ministry of Science, Energy and Technology, and Trend Micro. The initiative promoted the development of cybersecurity skills in the Information and Communications Technologies industry (ICT).
- Taking into account CICTE's previous support to the Government of Jamaica in the development of the National Cybersecurity Strategy (NCS) which was published in 2015. Most recently, in 2021 OAS CICTE provided technical support, in collaboration with the National Cybersecurity Task Force, with the review of the National Cybersecurity Strategy including facilitating virtual multistakeholder engagements to identify the country's evolving cybersecurity needs and priorities. This effort resulted in the redraft of the NCS with expected approval by end of 2022/ 2023.
- The Jamaica Cyber Incident Response Team (JaCIRT) has been an active member of CICTE's hemispheric network of public Cyber Incident Response Teams (CSIRTs) in OAS Member States, also known as CSIRTAmericas, since 2016 and continues to participate in activities including the recent Heads of CSIRTs meeting held in October.
- 13 officials have participated in 8 cyber diplomacy courses over the last 2 years.

- Project objectives: PACAM is a comprehensive strategy of DPS/OAS to reduce armed violence through:
  - Improvement of national capacities and firearms control systems on (i) marking, recordkeeping, and tracing of firearms; (ii) physical security and management of the stockpiles of firearms, ammunition, explosives, and other related materials, including the destruction of firearms; and (iii) regional coordination and information exchange to optimize firearms control.
- Strengthening community resilience to armed violence and reducing unauthorized access to firearms.
- Project description: This is a comprehensive initiative that offers support to OAS

Member States in complementary aspects of firearms control to contrite with the reduction of armed violence in the hemisphere. Jamaica has expressed interest in some components of the project, including legislative assistance, and training in Physical Security and Stockpile Management. Further support is available to Jamaica if the authorities are interested, including in the destruction, and marking of firearms.

- Project duration (Start date/End date): July 2022 to May 2025
- Total Budget allocation (in case of regional projects, please specify allocation for component in Jamaica): The European Union has granted more than EUR4 million to fund PACAM. The allocation for Jamaica will depend on the support required for Jamaica, to be determined by national authorities.
- Disbursement in Jamaica in 2022: During the current Phase, there were no specific activities funded in Jamaica.

### Project Status

- Status of implementation (Started/ on target/not on target; Outputs and activities achieved): The implementation of Phase II started on July 2022. During Phase I, assistance was offered to Jamaica with the following results:
  - Technical support was provided to the Ministry of National Security (MNS) to update the firearms normative framework: DPS/OAS has carried out three rounds of legislative review, including suggestions for improvements to the new Firearms Act. The new Firearms Act was approved by Jamaica during the second semester of 2022.
  - Participation of two representatives of MNS in the technical committee to review the Regional Communication Mechanism on Licit Transfers of Firearms and Ammunition (MCTA). Their inputs have been fundamental to ensure the MCTA is aligned with the priorities of the country



and can be deployed in Jamaica once the electronic system is developed.

- Participation of a representative of Jamaica on the Virtual Coordination Network for information exchange on illicit firearms trafficking.
- Training of police officers from the Jamaica Constabulary Force (JCF) in the one-week virtual course of Basic Notions of Explosives and Good Practices, in partnership with the National Police of Spain.
- Training of officers from JCF, and Jamaica Defense Force (JDF) in the one-week virtual training on Physical Security and Stockpile Management.
- Main challenges: During Phase I, the impact of the pandemic (with the restrictions), the turnover of personnel, at the national level, and budgetary constraints were the main challenges to sustaining the progress achieved by the project.

Project objectives: The Bureau of Oceans and International Environmental and Scientific Affairs (OES) of the Department of State of the United States, requested the DTOC to develop a project to raise awareness of the problem of illicit mercury trafficking in small-scale artisanal mining, and to create spaces for discussion on the status of the implementation of the Minamata convention in the Americas.

Project description: In development of this project, the DTOC organized the Hemispheric Dialogue on the Problem of the Illicit Importation of Mercury for Gold Mining in the Americas, in which delegates from 27 OAS member and observer countries participated, and in which the main problems causing mercury traffic and experiences of the countries of the region for its control were presented. One (1) Jamaican government official participated in this event.

As a second activity, the DTOC held the “Regional Workshop on Irregular Trade and Storage of Mercury for Illegal Mining: Current Risks and Trends” in Lima, Peru in October 2022. This workshop was



attended by experts from Colombia, Costa Rica, Ecuador, Panama and Peru; in which a document with conclusions and recommendations was prepared to improve mercury trade control mechanisms in the region.

**Activities for 2023:**

The DTOC will carry out in 2023 a “Regional Workshop on Irregular Trade and Storage of Mercury for Illegal Mining: Current Risks and Trends” for the Caribbean, in which Jamaica will be one of the beneficiary countries. The DTOC will contact the Permanent Mission of Jamaica to the OAS to obtain the nomination of one representative of the authority responsible for the implementation of Minamata convention and one prosecutor in charge of investigating cases of illegal mining.

Total overall budget allocation of the project: \$340,000.00

**Project title:** Establishment of an Asset Recovery Network for the Caribbean (Phase 2)

**Project objectives:** This initiative derives from the creation of the Asset Recovery Interagency Network for the Caribbean (ARIN-Carib) in 2017. ARIN-CARIB has seen a series of successes, such as the collaboration between more than 60 law enforcement and judicial experts, and the establishment of more efficient information-sharing systems. However, money laundering is continuing

to adapt to the most innovative technologies. Therefore, the workshop will address the constant adaptation of transnational crime to technologies such as cryptocurrency, as well as current issues of interest for ARIN-CARIB jurisdictions, including the management of assets of illicit origin.

**Project description:** The DTOC, in collaboration with the Regional Security System (RSS) and with the financial support of the United States Department of State, is implementing a virtual workshop on asset recovery, in which all Caribbean members of both organizations are beneficiaries.

This virtual event was preliminary organized for October 2022, and Jamaica confirmed participation of 4 representants, but the activity was finally postponed to 2023.

**Activities for 2023:**

In this context, the DTOC will carry out a Workshop on asset recovery for ARIN-CARIB jurisdictions in 2023 and will contact the Permanent Mission of Jamaica to the OAS to confirm the final nomination of 6 participants with the following profiles: 2 prosecutors from the Attorney General’s Office; 2 financial intelligence analysts from the Financial Intelligence Unit; and 2 officers from the agency responsible for the administration of seized and forfeited assets.

Total budget allocation of the activity: \$4,434.25

- **Concrete benefits for Jamaica (Results Area, incl. beneficiaries' age and gender, if applicable):** As a member of the RIAL, the Ministry of Labour, and Social Security (MLSS) of Jamaica has been able to obtain valuable technical assistance, share and obtain knowledge and expertise, and strengthen institutional programs through the participation in 22 Hemispheric Workshops, 3 Virtual Dialogues, and 9 Bilateral Cooperation missions, among others. Additionally, by being part of the RIAL, Jamaica has access to Portfolios and information repositories produced by the Technical Secretariat to learn as well as to share its own programs in all priority areas of labor administration, including labor inspection, occupational health and safety, eradication of child labor, and youth employment, among many others.
- **Project objectives:** The main objective of the RIAL is to strengthen the human and institutional capacities of labor administration in the Americas.
- **The specific objectives are:** identify, organize and disseminate the experience and knowledge of the Ministries of Labor of the Hemisphere; collect and systematize information regarding programs and projects in priority topics for labor administration; foster critical transferring of the various experiences and lessons learned through workshops and cooperation activities among countries; facilitate communication between Ministries of Labor, international organizations, financial agencies, workers and employers representatives and civil society; improve the ability of the Ministries of labor to identify their institutional needs and formulate proposals to receive technical and financial assistance; strengthen coordination and collaboration among international organizations and cooperation agencies.

MLSS representatives also participated in 2 Virtual Dialogues on Gender among Ministries of Labor, focused on the creation of a network of Gender focal points and strengthening a gender-responsive labor inspection. Furthermore, MLSS sent valuable information to launch and update Jamaica’s section of the Open Portfolio on Telework Legislation and Regulations and is updating its information in the RIAL’s Portfolio of Programs. - History of participation: As of 2022, representatives of Jamaica to the RIAL have participated in 22 out of 26 RIAL Workshops and 3 Virtual Dialogues. The MLSS has provided cooperation on 7 instances to 7 different countries on topics ranging from youth employment, labor market information systems, and Temporary Workers Programs, among other topics. It has received technical assistance from the United States Department of Labor on compliance with labor laws for the inclusion of vulnerable populations, and from the Ministry of Labor of Colombia on labor market information systems. Finally, MLSS currently offers 2 programs (on information and research, and child labor) in the RIAL Portfolio of Programs.

## The Development Cooperation Fund (DCF)

### Program Cycle 2021–2024

The Management Board of the Inter American Agency for Cooperation and Development (IACD) approved the “Inclusive Resilience for an Effective Recovery, with a Focus on Science and Technology” as an Area of Action for the programming cycle of the OAS/DCF 2021–2024 (AICD/JD/DE-126/20) with four Program Themes:

1. Retooling MSMEs through innovation and technology.
2. Innovative Reskilling for Tourism sector recovery and regional economies.
3. Scientific and technological innovation for building resilience.
4. Science for decision making in disaster risk planning.



The area of action and corresponding themes were approved by CIDI at its regular meeting, held on December 8, 2020 CIDI/doc.304/20 rev.1.

A seed fund totaling US\$1.8 million for the 2021-2024 programming cycle was approved for the DCF Program cycle 2021-2024. Eighteen countries are eligible to participate in the DCF/OAS Programming cycle 2021-2024 Cycle to develop a program on one of the four program themes.

**Concrete benefits to Jamaica:** A US\$100,000 DCF grant, under Program I: Retooling MSMEs through innovation and technology, was awarded to Jamaica for a MSME's development project, which aims to support one hundred MSMEs in Jamaica in adopting technological and non-technological tools to improve their competitiveness, market reach, boost their productivity and enhance their resilience. The project is being implemented by the Jamaica Business Development Corporation (JBDC).

Outcomes / Achievements: The High-Level Policy Forum was successfully organized in collaboration with the Ministry of Tourism of Jamaica and the Caribbean Hotel and Tourism Association, and held in Montego Bay, Jamaica. All thirteen participating project countries participated in the High-level Forum for the validation of the findings and recommendations from the holistic assessment survey of over 600 Small Tourism Enterprises, validation of the challenges to post disaster business continuity of Small Tourism Enterprises, and validation of the procedures for crisis communications and business continuity planning. The high participation rate included both in-person delegates



(70) and remote participants (159). The project's findings and recommendations were distributed to beneficiary countries through official channels on November 18, 2022.

Benefits for Jamaica: Jamaica is already the leader in the region, and globally on the issue of resilience, and hosting this event provides an opportunity to share the project's results among not just the project countries but the broader OAS membership.

Project Objective: help communities to prepare and respond to disasters by providing them with an organizational structure, lifesaving and preparedness skills and knowledge to minimize human life, economic and livelihood losses. CERTs also help communities to minimize damage to homes and losses of personal assets to help restore basic services and communications, and to be ready to go back to work in a more efficient and timely manner.

Concrete benefits for Jamaica: the CERT in Jamaica continue to forge collaboration among all stakeholders including transportation, tourism services, recreation and entertainment,

accommodation as well as within the local communities where livelihood depends on tourism and empowers the communities where the training was held into formal disaster preparedness and response teams.

Outcome and achievements: 18 females and 11 males were trained. All participants became CERT certified after the training was concluded.

SEDI/DSD partnered with the IDB, UNEP, GIZ, and the Secretariat of the Cartagena Convention to execute the GEF project "The Caribbean Regional Fund for Wastewater Management," with the Wider Caribbean Region (Barbados, Belize, Colombia, Costa Rica, Cuba, Dominican Republic, Grenada, Guatemala, Guyana, Honduras, Jamaica, Mexico, Panama, Saint Kitts and Nevis, St. Lucia, St. Vincent and the Grenadines, Suriname, and Trinidad and Tobago). SEDI/DSD is responsible for the overall coordination of the project while Barbados leads the development of a National Communications Strategy (and associated implementation plan) for Integrated Water and Wastewater Management, an environmental evaluation for a Wastewater Revolving Fund, and the development of a co-financing/revolving fund mechanism to support uptake of wastewater treatment and reuse programs.



SEDI/DSD published the guide “**Good practices for climate change mitigation and adaptation in Latin America and the Caribbean: concept, methodology and experiences to strengthen the human dimensions of Nationally Determined Contributions,**” a Technical Cooperation project between the OAS and IADB led by **Jamaica**, Costa Rica, and Uruguay.

## Department of Economic Development (DED)

### Science, Technology, and Innovation (STI)

- Authorities of the Inter-American Committee on Science and Technology (COMCYT) were elected at the regular meeting of the Secretariat of the Inter-American Council for Integral Development (CIDI) held on August 30, 2022. The Honorable Daryl Vaz, Minister of Science, Energy, and Technology of Jamaica was elected as Chair; and Dr. Benjamin Abelardo Marticorena Castillo, President of the National Council for Science, Technology and Technological Innovation (CONCYTEC) of Peru, and Dr. Flavio Salazar Onfray, Minister of Science, Technology, Knowledge, and Innovation of Chile, as Vice Chairs.
- The COMCYT Work Plan 2022–2024 was agreed by the COMCYT Authorities and the Troika during the Planning Meeting of the Authorities of the CIDI Ministerial Process of Science and Technology held on November 2, 2022. The Work Plan establishes a roadmap to implement the mandates in the **Declaration of Jamaica**: “Harnessing the Power of Transformative Science and Technologies to Drive our Communities Forward,” adopted during the Sixth Meeting of Ministers and High Authorities of Science and Technology, held virtually on December 7–8, 2021. The main areas for action include addressing youth skills gap and readiness for industry

4.0; promoting the inclusion of women, rural and indigenous communities, and other populations in vulnerable situations in STI; technology foresight as input for public policy decisions; and effective public–private–academia collaboration to enhance quality of life and MSMEs through STI.

- The OAS Youth Academy on Transformative Technologies in collaboration with Meta launched three modules of a course on Augmented Reality (AR) to provide training and certification for 10,000 youth from the Americas. The three-level course and certification are offered in English, Spanish and Portuguese and feature instruction on AR basics, fundamentals and pro levels with content developed with use cases and experiences of local creators from Latin America and the Caribbean. The purpose of the OAS Youth Academy is to prepare youth of the Americas for jobs and entrepreneurial opportunities of the digital and innovation economy as provided in the **Ministerial Declaration of Jamaica**. More than 20,000 participants from all 34 OAS Member States registered in the OAS Youth Academy in 2022. Additional course offerings are set to become available in 2023 and 2024 in collaboration with other partners including Structuralia.
- **Jamaica participated in a High-Level Conference on raising the awareness and understanding of how Science and Data can shape policies for building resilience and disaster risk management in the Caribbean**, organized by the OAS. Jamaica was one of the nine Caribbean countries (The Bahamas, Barbados, Belize, Dominica, Jamaica, St. Lucia, Suriname and Trinidad and Tobago) that participated in the in-person event hosted by the government of Dominica.


2022 Activities in which Jamaica has participated:

Once the gaps are identified, the training offer will be tailored to match it with the highest demanded digital skills per sector. The project will focus on sectors in Jamaica where the challenges and opportunities for innovation are greatest: tourism, manufacturing, and food processing, to name a few. The project will offer training in four broad categories (i) digital skills based on the needs of the SMEs; (ii) soft skills training; (iii) freelancing; and (iv) entrepreneurship.
