
**What are NPS?**





# FUTUROS DESAFÍOS PARA ASESORÍA DE ALERTA TEMPRANA DE LA UNODC SOBRE NSP



- Garantizar un flujo constante de datos sobre NSP a partir de una amplia gama de fuentes (enlaces a mecanismos nacionales y regionales de información)
- Capturar información más sistemática sobre riesgos y daños (información farmacológica y toxicológica)
- Apoyar la transición de "NSP" bajo fiscalización dentro de los mecanismos de recopilación de datos internacionales existentes (por ej., ARQ)
- Responder a la demanda de laboratorios e instituciones encargadas de hacer cumplir la ley para mejorar su capacidad de identificación y detección de NSP

## RESULTADO

- El aviso de alerta temprana de la UNODC sobre NSP contribuyó a la identificación de NSP para una lista corta de revisión internacional utilizando criterios tales como la prevalencia geográfica y la persistencia de NSP
- Impacto: la discusión sobre el control internacional de NSP se centra en un número manejable de sustancias (NSP más prevalentes, persistentes y perjudiciales)

## UNODC Early Warning Advisory (EWA) Tox-Portal


As a new feature of the UNODC Early Warning Advisory (EWA) on new psychoactive substances (NPS), the EWA Tox-Portal is an innovative tool to collect, analyse and share data on toxicology and harm related to the use of NPS at a global level.

In collaboration with [The International Association of Forensic Toxicologists \(TIAFT\)](#) and other partners, the Tox-Portal is designed to generate timely information on the harms and adverse health consequences associated with the use of NPS, based on case reports of intoxications, including fatalities.

Information from the Tox-Portal will contribute to identifying the most *harmful* NPS as an important step towards prioritizing NPS for international review in the framework of the [International Drug Control Conventions](#).
