Secretary for Multidimensional Security, OAS

Ms. Urrutia came to the OAS following a distinguished career in public service in Panama, including positions as Director of International Legal Affairs and Treaties and Acting Vice Minister of Foreign Affairs. Ms. Urrutia served as the Principal Representative of the Government of Panama to the Permanent Council of the OAS, the Inter-American Commission on Human Rights (IACHR) and the Inter-American Court of Human Rights. She was selected as one of Panama's leaders for the IDB initiative "Mujeres Líderes Emergentes del Sector Público BID-INCAE" (2017). Ms. Urrutia holds a Ph.D. in Law from the Carlos III University of Madrid. She is an Attorney. She was Professor of Antitrust Law and Consumer Protection at the Santa Maria La Antigua University (Panama) and Professor of Public Service Law at the Latin University (Panama).

Ambassador of Canada in Costa Rica

Prior to his assignment as Canada's Ambassador to the Republic of Costa Rica with cross accreditation to the Republics of Honduras and Nicaragua, Mr. Hill served abroad as Consul General in Seattle; Chargé d'affaires at the Embassy of Canada in Kuwait; Deputy Head Mission at the Embassy of Canada in Kabul, and Chargé d'affaires at the Embassy of Canada, Tripoli, among others. At Global Affairs Canada in Ottawa, Mr. Hill held management positions as Director for Middle East & Africa Commercial/Economic Relations, Director for Europe & Central Asia Commercial/Economic Relations, Deputy Director of the Latin America Division and Deputy Director of the Western Hemisphere Summits Office. Amb. Hill has a BA degree in History from the University of Saskatchewan, as well as a Post Graduate Diploma in International Studies form the University Cândido Mendes, Rio de Janeiro, Brazil.

He joined the General Francisco de Paula Santander Cadet School on January 23, 1995, completing his training on November 4, 1997. He is a business administrator and police administrator, a specialist in Senior Management, holds a Master in Public Security, a Diploma in International Senior Management and a Peace Operations and Joint Operations course in the United States. Throughout his professional career, Lt. Col Montaño has held positions such as police pilot, university professor, Criminal Investigator, liaison officer and advisor of the Ministry of Foreign Affairs / Migration Colombia and Deputy Attaché of Police in Chile. He is currently Director of the Regional Counterdrug Intelligence School of the Americas ERCAIAD, based in Colombia.



#### **Rhea Reid-Bowen**

Program Coordinator, Regional Security System (RSS)

Ms. Rhea Reid-Bowen is currently employed at the Regional Security System (RSS) Headquarters in Barbados as Programme Coordinator, with responsibility for the management of RSS programs/projects emanating from strategic plans of the organisation. Eric has become one of the leading law enforcement subject matter experts of illicit Fentanyl in Canada and authored the RCMP national safe handling guidelines for Fentanyl. Eric has presented the issue of Fentanyl to police agencies across Canada as well as the DEA, FBI and US Homeland Security.

Lieutenant Forero started training as officer of the Colombian National Army in the Military School of Cadets "General José María Córdova" in 2011. In 2014 she ascended to the rank of Second Lieutenant of the Military Intelligence Branch. She was transferred to Army Aviation in 2017 for her outstanding operational achievements, where she was trained as rotary wing military pilot. She is currently a blackhawk team pilot, and is the first female helicopter pilot of the Colombian National Army. She currently carries out operations against drug trafficking, illegal mining, and supports troops on the ground. She has taken courses as military paratrooper, leadership at WHINSEC with the United States Army, military intelligence, interviewer analysis, patrimonial protection, judicial investigation techniques, senior management in security and risk prevention, among others. Likewise, she is a professional in military science and manager of security and socio-political analysis. In 2018 she rose to the rank of Lieutenant, and is part of the Air Assault Aviation Battalion.

### Lieutenant Commander Kele-Ann Bourne


Coast Guard, Defence Force, Trinidad and Tobago

In her work related to gender issues, she has been Head of the Office for the Defense of Women and Family Rights and Head of the Department of Domestic Violence of the Judicial Police; participating in the "I World Conference on Women" in Beijing. Coordinator of Region 25 of South and Central America of the International Association of Women Police (IAWP). General (r) Daza is the first Latina woman to have held that position in the 100 years of creation of the international entity. In addition, she was advisor to the Inter-American Defense College in Washington D.C.



## Commander Héctor Quiche

Chief, Academic Unit of the Counterdrug School of DIRANDRO, National Police, Peru

Commander Héctor Quiche, serves as Head of the Academic Unit of the Drug School of the DIRANDRO PNP, based in Lima, Peru, since 2016, previously served as academic advisor to the Regional School of the Andean Community of Intelligence Antidrugs (ERCAIAD), from 2000 to 2011, at its former headquarters in Lima, Peru. # Inspector Isobel Granger

Trainer, Centre for Intercultural Learning, Global Affairs Canada

Isobel Granger was the Ottawa Police Service's first black woman promoted to the rank of inspector. Isobel grew up in Rhodesia (now Zimbabwe), where she began her policing career. In 1989, Isobel immigrated to Canada with her family. She was promoted to the role of Inspector in 2018. Besides her policing duties, Isobel is a motivational figure in her community. She works to break down barriers for police, for racial inequality, and for women. Her work has been recognized with many awards. She has been the recipient of the Margaret Eve Leadership Award for Women in Law, the Black Leaders Leading Award from Profiles in Diversity Journal -- North America, the Martin Luther King DreamKEEPERS Citation for Outstanding Leadership, the Toastmasters International Communication and Leadership Award, the Black Women's Civic Engagement Network Community Leadership Award, and the Harry Jerome National Award for Public Advocacy. In 2015, she was inducted as a Member of the Order of Merit of the Police Forces. Most recently she wrote the book entitled Smashing the Glass Ceiling: A 10-step Guide Using Creativity and Innovation to Bust Through the Barriers to Female Leadership.



#### Bessy A. Mendoza

Coordinator, Drug Supply Reduction Unit, Investigations and Intelligence National Directorate, Honduras

Ms. Bessy Aracely Mendoza has served as Coordinator of the Drug Supply Reduction Area in the National Directorate of Research and Intelligence (DNII) for five years. She is in charge of the collection, validation, analysis and preparation of the Annual Report of the Honduran Observatory on Drugs, and is currently responsible for managing and developing the activities of the Inter-institutional Technical Board for the Reduction of the Supply of Drugs. She worked as an Intelligence Agent in the DNII, has a Diploma in Operational Intelligence Analysis, and a degree in Mathematics. She has participated in operations in the field of chemical precursors and synthetic drugs.



### Nalita Gajadhar

Programme Officer, Bureau of Gender Affairs, Barbados

Ms. Gajadhar is responsible for the Gender Mainstreaming Programme, where she plans and facilitates training in Gender Awareness and Gender Equality. Currently, she is working to train the Gender Focal points and establish the Interministerial Committee for gender mainstreaming for Barbados. Ms. Gajadhar has worked in the area of gender equality, for the past 30 years, in the NGO movement. She was President of the National Organisation of Women and BPW Barbados and has led the public discourse on gender equality with her work in broadcasting on the national television and radio call in programs. She also wrote a weekly column in the country's two newspapers for a number of years. Nalita Gajadhar holds a B.Sc. in Political Science (Hons) from the University of the West Indies. She works as a Tutor for the Institute of Gender and Development, Nita Barrow unit at the University of the West Indies Summer Program and lectures at the Bucknell University Summer Program.
