

**INTERNATIONAL ROAMING SERVICE RATES DATABASE**

The XXII Meeting of the Permanent Consultative Committee I: Telecommunications/Information and Communication Technologies (PCC.I),

**RECOGNIZING:**

- a) The importance that Member States may have information on the rates that are been applied by the international roaming service (voice, SMS and data) between Member States by the various operator companies offering mobile service, in such a way that their behavior in time may be assessed;
- b) The usefulness of having a database concentrating rate information applicable to the roaming service, which will be made available to all Member States so that they may use the information in the evaluations they wish to make,

**CONSIDERING:**

- a) That one of the topics of special interest in the issue of international roaming service refers to the level of rates that operator companies have been collecting;
- b) That in order to carry an evaluation of the rates that have been applied to international roaming it becomes necessary to initiate compilation thereof among Member States;
- c) That, as a pilot experience, compilation may be initiated of international roaming service rates, where the postpaid contractual modality applies as well as for international roaming communications between Member States, so as to later broaden the compiled information scope, depending on obtained outcomes,

**TAKING INTO ACCOUNT:**

That it will be beneficial for Member States to have a database of international roaming service rates, which is updated periodically, in order to evaluate its behavior,

**RESOLVES:**

- 1. To approve the creation of an international roaming service rate database.
- 2. To approve the International Roaming Rates Information Delivery Form, included in Annex, which includes information on the lowest rate applied to outgoing and incoming calls and SMSs to and from the country of origin, as well as the lowest rate applied to data service for 1 Mbyte. Member States may attach technical notes in the Roaming Rates Information Delivery Form so as to clarify the estimation methodology adopted.
- 3. To provide that the rates information to be delivered by Member States be the one in force by March 31, June 30, October 31, and December 31 of each year, which delivery must be fulfilled no later

than thirty (30) calendar days after the above mentioned dates. First delivery will be that of October 31, 2013 and will be submitted not later than November 30, 2013.

4. To designate Mr. Gonzalo Ruiz Díaz, Chairman of the Peru Administration (gruiz@osiptel.gob.pe), as the Coordinator of international roaming rates information compilation.

5. To request that CITEL Executive Secretary distribute among Members States the International Roaming Rates Information Delivery Form.

6. To request that CITEL Member States respond the International Roaming Rates Information Delivery Form.
