PCC.II/RES. 24 (V-99)⁵

Updating of the Blue Book on Telecommunication Policies for the Americas

The Fifth meeting of the Permanent Consultative Committee II: Broadcasting,

CONSIDERING:

- (a) That by Resolution of the COM/CITEL RES. 79 (VII-98) "Up-dating of the "Blue Book" on Telecommunication Policies for the Americas" it was resolved that the Blue Book on Telecommunication Policies for the Americas be updated;
- (b) That under that recommendation, the Chairman of COM/CITEL was charged with the necessary coordination with ITU Development Office, aiming to find the most appropriate mechanism for such updating; and
- (c) That under that recommendation, the Executive Secretary was charged with sending the document COM/CITEL/doc.390/98 to the chairpersons of Permanent Consultative Committees, so that they issue an opinion about the topics contained in the aforementioned document

TAKING INTO ACCOUNT:

- (a) That the aforementioned updating is required so that many countries of the Americas adopt Telecommunication Policies consistent with the changing environment of telecommunications;
- (b) That ITU Regional Office for the Americas is analyzing the updating of the aforementioned Blue Book; and
- (c) That the objectives of the PCC.II relate to Broadcasting, and therefore contributions made should be in accordance with this issue.

RESOLVES:

- 1. To nominate Mr. Juan Manuel Campos, from the Administration of Costa Rica, as rapporteur of the Chair of PCC.II, in order to coordinate and compile the information and concerns of Administrations and associate members (who are not in arrears with the payment of their fees) in connection with the Blue Book.
- 2. To request that the result of the rapporteur's report be presented to the Chair of PCC.II and to the Executive Secretariat, in September 1999.
- 3. To prepare a document that will be submitted to COM/CITEL, containing the suggestions of this Committee in connection with the updating of the Blue Book.

INSTRUCTS:

The Executive Secretariat of CITEL to distribute the present document, attaching supplementary information to be requested by the rapporteur from all Administrations and associate members of PCC.II, and inform them that suggestions will be considered only if sent to the rapporteur within a term of 45 days, at the latest.

PCC.II/RES. 25 (V-99)⁶

Representation of the PCC.II in Broadcasting Fora

The Fifth meeting of the Permanent Consultative Committee II: Broadcasting,

CONSIDERING:

- (a) That management of the radioelectric spectrum has become an increasingly important regulatory function, since radio frequencies remain a limited resource, and it becomes increasingly significant by virtue of technological development;
- (b) That the PCC.III approved resolution PCC.III/RES.81 (XII-99), adopting the procedure for representation of the PCC.III in Working Groups of other Regional organizations, aiming to exchange draft common proposals during the preparation of World Radiocommunication Conferences (WRCs) of the International Telecommunication Union (ITU);
- (c) That, based on the effective and efficient use of the radioelectric spectrum, in conjunction with the phenomenon of globalization and the convergence of telecommunication services, it is convenient and necessary to harmonize spectrum allocation policies, compatibility of new services, and assessment of methods, procedures and standards that may encourage the appropriate introduction of new technologically available services; and
- (d) That, when invited to participate in fora dealing with new radio and television broadcasting, it is advisable to consider the possibility that the PCC.II be represented in those events.

RECOGNIZING:

- (a) That the PCC.III has a Working Group focused on the preparation of common proposals from CITEL to the WRCs and the ITU; and
- (b) That CITEL, through the PCC.III has done a great job at the regional level, as concerns the preparation of common proposals in aspects related to the regulation of the radioelectric spectrum, to be presented to the WRCs and the ITU;

TAKING INTO ACCOUNT:

That Article 93, paragraph 10 of the Regulations of CITEL provides: "The Statutes and Regulations of CITEL allow each of the PCCs to change and adapt its work methods to most efficiently meet the needs of its members";

RESOLVES:

- 1. To ratify the procedure attached concerning representation at Working Groups of other Regional Agencies, aiming to exchange preliminary common proposals in preparation of World Radiocommunication Conferences (WRCs) and meetings of the International Telecommunication Union (ITU), on issues related to Broadcasting.
- 2. To adopt the procedure detailed in the Annex to this Resolution, applicable to representation of the PCC.II in the different international fora dealing with broadcasting.

INSTRUCTS THE EXECUTIVE SECRETARIAT:

- 1. To distribute this resolution and its annex to CITEL Member States and to associate members of the PCC.II.
- 2. To invite other regional agencies concerned with broadcasting to participate in meetings of the PCC.II, in order to facilitate regional and international exchange of views and positions.
- 3. To refer this resolution to other Permanent Consultative Committees, for consideration.

ANNEX

PROCEDURE FOR REPRESENTATION OF THE PCC.II IN DIFFERENT BROADCASTING FORA

RECEIVING THE INVITATION

1. The Chairman of the PCC.II will forward to the Chair of COM/CITEL and to the Executive Secretariat of CITEL any formal invitation received for participation in different broadcasting fora.

COMMUNICATION TO MEMBER STATES AND ASSOCIATE MEMBERS ABOUT THE INVITATION

- 1. The Executive Secretariat, not later than five (5) days following receipt of the invitation, shall send a note, signed by the Chairman of the PCC.II, to contact persons in Member States, informing them about said invitation, mentioning the place, date, and agenda of the meeting. The Chairman of the PCC.II shall request them to inform, by a given date, the name of the person(s) interested in attending such meeting.
- 2. The Executive Secretariat, not later than five (5) days following receipt of notices from Member States, shall send a note, signed by the Chairman of the PCC.II, to the inviting forum, informing the name of the person(s) who will represent the PCC.II at that meeting. A copy of this note shall be sent to those attending as representatives of the PCC.II, and to the Chair of COM/CITEL.

WHO SHOULD PARTICIPATE

- 1. It is understood that the representative of the PCC.II should attend the meeting on behalf of the PCC.II.
- 2. The delegations shall always consist of at least one representative of one Member State.
- 3. In case no representative is available to attend the meeting, the Executive Secretariat shall inform the inviting forum that nobody will attend on behalf of the CITEL.
- 4. The PCC.II may be represented by:
 - a) The Chairman of the PCC.II
 - b) The Vice-Chairmen of the PCC.II
 - c) The Chairman of the Working Group relevant to the issue concerned
 - d) The Vice-Chairman of the Working Group relevant to the issue concerned (if applicable)

- e) Coordinators and rapporteurs, and those delegates identified by the Member States of CITEL in consultation with the President of the PCC.II, and who have participated, at least in the last meeting of the Working Group.
- 5. In order to avoid disturbances to the inviting forum, the Chairman of the PCC.II shall carefully consider the number of representatives to attend, taking into consideration the issues to be addressed, as well as the organization and structure of the work that is being developed at the relevant Working Group.

OBLIGATIONS OF THE REPRESENTATIVE/S

- 1. Taking into consideration the issues to be addressed in the inviting forum, as well as the structure and organization of work underway at the relevant Working Group, the Chairman of the PCC.II, in consultation with the Chairman of the Group, as provided for in 8 above, shall appoint one member of the delegation of CITEL to act as spokesperson, in order to present the report about the progress of work in the sphere of the CITEL.
- 2. The representative(s) shall also report about the following:
 - a) Within ten (10) days, a summary on the results of the forum, to CITEL Member States, through the Executive Secretariat;
 - b) The activities carried out during the forum, at the subsequent meeting of the PCC.II. Moreover, the report shall be included in the documents to be submitted to the meeting of the PCC.II, and in the CITEL web page.

PCC.II/RES. 28 (V-99)9

Creation of the Forum on Broadcasting Policies in the Americas

The Fifth meeting of the Permanent Consultative Committee II: Broadcasting,

CONSIDERING:

- (a) Resolution COM/CITEL RES.68 (VII-98) that sets forth the strategic objectives, general policies and strategic priorities of the Organization for the 1999-2003 period, as well as the objectives of PCCII;
- (b) Resolution COM/CITEL.RES 74 (VII-98) that establishes the guidelines for the Chairpersons of PCCs in coordination with ITU; and
- (c) The outcome of the Summit of the Americas, that provides for the need to create for on telecommunication policies in the region.

TAKING INTO ACCOUNT:

- (a) The objective of PCCII, that is to act as the advisory technical organ within the Inter-American Telecommunication Commission on issues related to standard coordination, planning, operations and technical assistance to the various modes of Broadcasting Services; and
- (b) The mandates on the identification of the Service's development needs in the Region, the promotion of the efficient use of the radiolectric spectrum allocated to the Broadcasting

Service, the development of a coordinated work with the various CITEL groups, and the preparation of ITU regional conferences and meetings.

RESOLVES:

- 1. To hold a forum on Broadcasting Policies involving all public and private sectors, for the purpose of compiling all the necessary related expertise and information, which should take place during the year 2000, in a place and date to be confirmed.
- 2. To request the Administration of Uruguay to nominate a representative as coordinator of said event.
- 3. That this forum should prepare a report containing its conclusions, to be submitted to PCC.II, and taken into future consideration for the establishment of service policies, regulatory frameworks and technical aspects.
- 4. To request the coordinator to work in close contact with the chairpersons of the Committee's working groups and the Chairman of the Committee.
- 5. To request the coordinator to submit a preliminary calendar to the Chairman of the Committee, in due time so as to be circulated during the next COM/CITEL meeting.

PCC.II/RES. 29 (V-99)10

Common Views of CITEL on Terrestrial Broadcasting Issues

The Fifth meeting of the Permanent Consultative Committee II: Broadcasting,

CONSIDERING:

That only a few CITEL Member States participate in meetings and activities developed at ITU-R Study Groups 10 and 11, and its corresponding Working Groups;

RECOGNIZING:

- (a) That at ITU-R related meetings and Conferences dealing with terrestrial broadcasting issues, CITEL Member Sates generally present their positions individually, resulting in less than full support for their proposals;
- (b) That it is important for CITEL Member States to adopt a common approach on sound and television broadcasting; and
- (c) That in order to achieve this purpose, it is also required that rapporteurs act as a liaison to provide information to CITEL Administrations, in order to assure feedback on the group's work, and finally prepare common proposals for further submittal to different fora.

RESOLVES:

- 1. To encourage CITEL Member States to actively participate in the work of the ITU in the area of broadcasting.
- 2. To request those CITEL Member States that are able to participate in ITU meetings, to inform subsequent PCC.II meetings about the status of work developed.
- 3. To urge CITEL Member States to develop, where possible, common proposals on terrestrial broadcasting that would be presented in other fora, such as the ITU-R.

PCC.II/RES. 30 (V-99)11

Creation of a Working Group for Studying the Implementation of a Digital Television Service

The Fifth meeting of the Permanent Consultative Committee II: Broadcasting,

CONSIDERING:

- (a) That the evolution of digital technology makes possible the fast implementation of DTV systems;
- (b) That there is the need to compile technical data on studies, experience and field tests for future DTV implementation plans;
- (c) That the acquisition of information on regulatory plans for the implementation of the DTV service is of great importance;
- (d) That the impact of spectrum migration in each Member State in the Region should be taken into consideration:
- (e) That it is advisable to count on an orderly conversion process from the analog to the digital system;
- (f) That some countries in the region have already authorized experimental emission tests and are currently planning the granting of licenses for DTV operation;
- (g) That such systems will become operational in the very near future; and
- (h) That common goals should be agreed upon in CITEL for the benefit of its members,

RESOLVES:

- 1. To revoke resolution PCC.II/RES.16 (IV-98) "Creation of a Working Group in PCC.II for studying the implementation of the digital terrestrial television service".
- 2. To create a Working Group for the Implementation of the Digital Television Service.
- 3. To designate Mr. Miguel Angel Pesado, from the Administration of Argentina, as Chairman of said Group.
- 4. To establish the following terms of reference for the Working Group:
 - a) To identify the current status of DTV at the regional level, as well as implementation projects for these systems.
 - b) To follow up the activities and studies being conducted at the ITU, particularly those related to Region 2, and the studies undertaken within the environment of sub-regional organizations.
 - c) To compile agreements, conventions, working documents, recommendations, experimental tests and results of test measurements carried out by the states and subregions, for the purpose of making them available to the Member States of the PCC.II of CITEL.
 - d) To evaluate the outcome of test programs.
 - e) To prepare guidelines according to the particular conditions in each country, for a more orderly implementation of services in Region 2.
 - f) To promote an adequate information exchange with sectors developing specific work on these issues.
 - g) To follow up standards in order to determine those that would be most suitable for meeting the needs of Region 2.
 - h) To provide for the presentation of reports covering the above mentioned issues.
- 3. To appoint the following Rapporteurs in order to support the Chairman of the Working Group in the fulfillment of the Group's mandate:

Rapporteur on subscriber Television

Rapporteur: Mr. Ivan Roberto Pena Pereira (Brazil)

Rapporteur on satellite Television

Rapporteur: Mr. Juan Manuel Campos Avila (Costa Rica)

Name: "Broadband Wireless Systems in a Fixed Service operating on Frequency Bands above 20 GHz in Radio Broadcasting".

Terms of Reference:

- a) To study the allocation of the most appropriate frequency bands for the "Broadband Wireless Systems in a Fixed Service operating on Frequency Bands above 20 GHz in Radio Broadcasting", and coordinate conclusions with PCC.II.
- b) To coordinate the standardization of technologies to be implemented.
- c) To prepare guidelines for the uniform implementation of "Broadband Wireless Systems in a Fixed Service operating on Frequency Bands above 20 GHz in Radio Broadcasting", in the American Hemisphere.
- 1. To designate Mr. Lenin Andrade Quiñones, from Ecuador, as Coordinator of the activities of this Group with PCC.III.

INSTRUCTS THE EXECUTIVE SECRETARIAT:

To inform on this Resolution the Chairperson of PCC.III, with copy to the Chairman of Working Group, Mr. Winston Ragbir (Trinidad and Tobago).
