Dear representatives of the indigenous peoples of the Americas,

The Department of International Law of the Secretariat for Legal Affairs of the General Secretariat of the Organization of American States presents its compliments on behalf of the Chair of the Working Group to Prepare the Draft American Declaration on the Rights of Indigenous Peoples and takes this opportunity to invite you to participate in the Thirteenth Meeting of Negotiations in the Quest for Points of Consensus, pursuant to operative paragraph 3 of General Assembly resolution AG/RES. 2565 (XL-O/10).

The Meeting of Negotiations will take place at OAS Headquarters in Washington, D.C., next January 18 to 20. It will be preceded by a meeting of the Indigenous Peoples' Caucus, to be held on January 15 to 16, 2011.

Individuals selected are required to be in Washington, D.C., between Friday, January 14 and Saturday, January 22, 2011.

In order to ensure the effective participation of the representatives of the indigenous peoples, the Department of International Law is advising you that the deadline for application to participate in the Meeting of Negotiations is **Friday, October 22, 2010, at 11:59 a.m.** (Washington, D.C. time).

In accordance with CP/RES. 951 (1691/09), which regulates "the Specific Fund to Support the Elaboration of the American Declaration on the Rights of Indigenous Peoples," **your community or organization should submit a letter addressed to the Department of International Law along with the all the documents requested in Appendix I to this Convocation.** The application should be prepared by the organization and the candidate together as there are requirements for both parties, but all documents should be sent in only once.

**Please remember that the letter of application should include the characteristics of the organization, its establishment, membership,**

Included in APPENDIX II, meanwhile, are the documents related to the negotiation process on the Draft American Declaration on the Rights of Indigenous Peoples.
