CHRONOLOGICAL ACCOUNT

A. BACKGROUND

- l. The Fourth Annual Meeting of the Inter-American Economic and Social Council at the Ministerial Level, which took place in Buenos Aires, Argentina, March 25 through April 1, 1966, approved the Special Declaration $1-M/66, \frac{1}{L}$ whereby the Secretary General of the Organization of American States was instructed to consult with the governments of the member states on the advisability of holding a meeting of the Chiefs of State of the countries of the inter-American system, in order to lend more effective political thrust to the objectives of the Alliance for Progress and to agree upon the most appropriate measures for hastening their accomplishment.
- 2. At the regular meeting it held on June 27, 1966, the Council of the Organization heard an oral report presented by the Secretary General concerning the measures undertaken; it decided that the Secretary General should address the governments of the member states, through their representatives on the Council, to ascertain their viewpoints on the Special Declaration in question.2
- 3. At the special meeting the Council held on September 19, 1966, it noted that the replies received from the governments of the member states indicated that the peoples of the hemisphere were interested in holding a meeting of Chiefs of State that would adopt decisions aimed at facilitating economic and social development; it also took into account that Article 39 of the Charter makes provision for holding a Meeting of Consultation of Ministers of Foreign Affairs to consider urgent matters of common interest to the American states. The Council of the Organization therefore resolved to convoke the Eleventh Meeting of Consultation of Ministers of Foreign Affairs, under Article 39 of the Charter. The purpose of the Meeting of Consultation would be to decide whether to hold the Meeting of American Chiefs of State. That Meeting of Consultation was to be held within 90 days at the latest, but this deadline was extended by the Council at its special meeting on December 19, 1966.3/ At the special meeting held on January 13, 1967, the Council decided to set January 24 as the opening date for the Eleventh Meeting of Consultation of Ministers of Foreign Affairs.4/
- 4. For their part, the ministers of foreign affairs of the American republics and the Vice President of Bolivia, following an informal meeting in New York on September 23, 1966, issued a press release wherein they reasserted their governments' resolve to hold the meeting of American Chiefs of State on the date and at the place to be determined by the Eleventh Meeting of Consultation of Ministers of Foreign Affairs. 2/

- 5. At that special meeting of September 19, 1966, the Council established the Committee on Preparations for the Eleventh Meeting of Consultation of Ministers of Foreign Affairs, composed of all the delegations on the Council of the Organization. Bearing in mind the purposes of the Meeting of Chiefs of State, any proposals the governments might present in this regard, and the technical views of the highest ranking officials of the intergovernmental agencies and entities engaged in matters related to the topics that would be discussed—who were invited by virtue of that same decision—, this Committee was to prepare the necessary studies and draw up the corresponding preliminary drafts.
- 6. The Committee on Preparations was installed on October 11, 1966, and the Chairman and Vice Chairman of the Council were elected to serve as the Committee's Chairman and Vice Chairman until such time as the venue for the Meeting of American Chiefs of State was chosen. The Representative of Mexico was elected Rapporteur.

The Committee established two subcommittees: one to consider matters related to the Alliance for Progress, and the other to study economic integration.

At successive meetings of the Committee on Preparations, some formal and others private, viewpoints were exchanged and the invited high ranking dignaturies expressed their technical opinions.

7. At the meeting held on October 11, 1966, pursuant to the resolution approved on September 19, the Council decided to invite the following officials of intergovernmental agencies and entities, whose activities are related to the subjects that would be discussed at the Eleventh Meeting of Consultation of Ministers of Foreign Affairs, to lend their personal advisory assistance: José Mora, Secretary General of the Organization of American States; Felipe Herrera, President of the Inter-American Development Bank; Carlos Sanz de Santamaría, Chairman of the Inter-American Committee of the Alliance for Progress; Raúl Prebisch, Secretary-General of the United Nations Conference on Trade and Development; José Antonio Mayobre, Executive Secretary of the United Nations Economic Commission for Latin America; Alberto Solá, Executive Secretary of the Latin American Free Trade Association; Albino Román y Vega, Secretary General of the Organization of Central American States; Carlos Manuel Castillo, Secretary General of the Permanent Secretariat of the General Treaty on Central American Economic Integration; and Gustavo Guerrero, President of the Central American Bank for Economic Integration. —

Further, the Council authorized the Committee on Preparations to invite, on the former's behalf, other officials of intergovernmental agencies and organizations associated with this matter.

- 8. The outcome of the studies conducted by those officials was the document entitled "Ideas in the Economic-Social Area for the Meeting of Chiefs of State" 1/2, which was presented to the Council and sent to the governments. In cooperation with a group of experts, the General Secretariat prepared the document titled "Science and Technology as Factors in Latin American Development." Further, the Pan American Sanitary Bureau submitted suggestions on how to improve the well-being of the rural populace and the development of biomedical sciences and education in Latin
- 9. Moreover, the Committee on Preparations studied the draft resolution presented by the Delegation of Brazil on the multilateral nature of inter-American meetings, which was later approved by the Eleventh Meeting of Consultation of Ministers of Foreign Affairs at its meeting of January 25, 1967.2
- 10. The Committee on Preparations decided to present to the Eleventh Meeting of Consultation a recommendation to the effect that it be left to subsequent sessions of that Meeting of Consultation to decide the date and venue of the Meeting of Chiefs of State, as well as its program.
- 11. At the regular meeting held on February 1, 1967, the Council of the Organization transmitted the Report of the Rapporteur of the Committee on Preparations for the Eleventh Meeting of Consultation.4 on Preparations for the Eleventh Meeting of Consultation.
- At that meeting of February 1, 1967, the Council resolved to maintain the Committee on Preparations for the Eleventh Meeting of Consultation of Ministers of Foreign Affairs so that it might continue to act in accordance with the purposes established in operative paragraph 3 of the resolution adopted on September 19, 1966.4
- 13. At the regular meeting of January 24, 1967, the Council decided to include in the Regulations of the Meeting of Consultation of Ministers of Foreign Affairs, approved on March 1, 1951, a transitory provision to the effect that the Secretary General of the Organization would install the opening session when that Meeting of Consultation convenes at the headquarters of the Pan American Union. 2

B. FIRST SESSION

- 14. Pursuant to the resolution passed by the Council at its special meeting of January 13, 1967, the First Session of the Eleventh Meeting of Consultation of Ministers of Foreign Affairs was held at the headquarters of the General Secretariat between January 24 and February 1, 1967.
- 15. Members of the Meeting. During that First Session of the Eleventh Meeting of Consultation, the special delegates, counselors and technical advisors who appear in the corresponding list of participants were accredited. 1/

With observer status, the United Nations was represented at the Meeting by an alternate for the U.N. Secretary-General, in keeping with Resolution XXXIX of the Ninth International Conference of American States.

Dr. José A. Mora, Secretary General of the Organization, participated in the Meeting in accordance with Article 81 of the Charter.

- 16. President of the Meeting. At the preliminary session held on January 24, 1967, which was installed by the Secretary General of the Organization pursuant to the transitory provision in the Regulations, a decision was adopted to elect as President of the Meeting, for those sessions that would be held at the headquarters of the General Secretariat, Panama's principal representative on the Council of the Organization and its Special Delegate, Ambassador Eduardo Ritter Aislán. This decision was formally adopted at the opening session, which took place later. 2/
- 17. Secretariat of the Meeting. The Secretary of the Council, Dr. William Sanders, served as Secretary General of the Meeting, in accordance with the Transitory Provision of the Regulations. The Director of the Office of Council Secretariat Services and of Conferences, Mr. Santiago Ortiz, was designated Assistant Secretary General of the Meeting.
- 18. Committee on Credentials. At that preliminary session, it was decided that the Committee on Credentials would be composed of the special delegates of Guatemala, Mexico and Paraguay. This decision too, was formally adopted at the opening session. 3/
- 19. Coordinating and Drafting Committee. Pursuant to a decision adopted at the preliminary session and formally adopted at the opening session, the Coordinating and Drafting Committee was made up of the

On February 14, 1967, the President of the First Session of the Eleventh Meeting of Consultation of Ministers of Foreign Affairs, Ambas-sador Eduardo Ritter Aislân, sent a note to the Secretary General of the Organization, Dr. José A. Mora, whereby he transmitted the resolutions approved, the minutes of the sessions held, the Report of the Rapporteur of the Committee on Preparations and other documents from the sessions held at the headquarters of the General Secretariat, with the request that they be conveyed to the President of the Meeting when it resumed in Buenos Aires, Argentine.

C. SECOND SESSION

- 24. The Second Session of the Eleventh Meeting of Consultation of Ministers of Foreign Affairs was held in Buenos Aires, Argentina, February 15 through 26, 1967, in keeping with Resolution III/1, $\frac{2}{}$ approved during the previous session. In that resolution, it was determined that the Eleventh Meeting of Consultation would continue its sessions in Buenos Aires, on the occasion of the Third Special Inter-American Conference, which was to be held in Buenos Aires at the same time as the Eleventh Meeting of Consultation.
- 25. Members of the Meeting. At the Second Session of the Eleventh Meeting of Consultation, the Ministers and Secretaries of State of Foreign Affairs and their counselors and advisors who appear in the list of participants were accredited. 3

The Secretary General of the Organization, Dr. José A. Mora, participated in the proceedings in accordance with Article 81 of the Charter.

Also participating in the Meeting was the Assistant Secretary General of the Organization, Dr. William Sanders.

On an observer basis, the United Nations was represented at the Meeting by an alternate of the Secretary General, in accordance with Resolution XXXIX of the Ninth International Conference of American States.

26. President of the Meeting. Pursuant to Article 8 of the Regulations, the President of the Republic of Argentina designated the Minister of Foreign Affairs and Worship, Dr. Nicanor Costa Méndez, as provisional President of the Meeting of Consultation, he was elected Permanent President at the first plenary session, following a decision adopted to that effect at the preliminary session. $\frac{4}{}$

27. Secretariat of the Meeting. Pursuant to Article 10 of the Regulations, the Government of Argentina designated Ambassador Luis Santiago Sanz as Secretary General of the Meeting and Ambassador Guillermo de la Plaza as Assistant Secretary General.

For his part, the Secretary General of the Organization designated Mr. Santiago Ortiz, Director of the Office of Council Secretariat Services and of Conferences as Assistant Secretary General of the Meeting.

- 28. Documents from the First Session. The Meeting took cognizance of the letter that the President of the First Session, Ambassador Eduardo Ritter Aislán, addressed to the Secretary General of the Organization to convey the resolutions approved, the proceedings of the sessions, the Report of the Rapporteur of the Committee on Preparations and other documents from that First Session held at the headquarters of the General
- 29. Program for the Meeting. At the first plenary session, it was decided that the purpose of the Meeting was to comply with paragraph 1 of the resolution approved during the First Session, whereby it was decided to continue the sessions in Buenos Aires "to enable the Ministers of Foreign Affairs themselves to adopt the measures necessary concerning the agenda, site and date of the meeting of Chiefs of State. . . $^{0.2}$
- 30. Regulations of the Meeting. During the preliminary session, it was decided to ratify the Regulations of the Meeting of Consultation of Ministers of Foreign Affairs approved by the Council of the Organization on March 1, 1951, with the addition of the transitory provision for the Eleventh Meeting of Consultation and incorporated by the Council on January 24, 1967.3
- 31. Order of Procedence. At the preliminary session, it was decided that the order of precedence of the First Session would be applied during the Second Session of the Eleventh Meeting of Consultation. The Delegation of Argentina requested that it figure last in the order of precedence.
- 32. Committee on Credentials and Coordinating and Drafting Committee. At the preliminary session, it was decided that both committees would be made up of the same delegations that served on those committees at the First Session. This decision was formally adopted at the first plenary session, held the next day. 5

- 33. Sessions. During the Second Session of the Eleventh Meeting of Consultation of Ministers of Foreign Affairs, the following sessions were held: a preliminary session, one plenary session and a closing session. At the last of these, the Report of the Rapporteur of the General Committee was presented and the recommendations made by the General Committee were approved. 1
- 34. General Committee. During the course of the first plenary session, it was decided to establish a General Committee, made up of all the delegations, and empowered to form such working groups as it deemed necessary.

The General Committee elected the following as its officers:

The General Committee held five meetings. 2/ It formed an advisory group composed of the delegations of Argentina, Brazil, Chile, Colombia, El Salvador, Mexico and the United States. It also set up a drafting group composed of the delegations of Chile, Colombia, Guatemala, Mexico and the United States, and another composed of the delegations of Argentina, Brazil, Panama, Peru and the United States.

35. <u>Decisions</u>. As a result of the deliberations during the Second Session, the Eleventh Meeting of Consultation of Ministers of Foreign Affairs approved the following resolutions:

In accordance with Resolution I/2, the Eleventh Meeting of Consultation of Ministers of Foreign Affairs decided to recommend that the Meeting of American Chiefs of State be held in Punta del Este. Uruguay, April 12 through 14, 1967; it approved its agenda and decided to form a special committee made up of the personal representatives of the Chiefs of State, whose terms of reference would be the guidelines contained in Document 33 rev. 2^{1} / of the Meeting of Consultation, for the exposition of the agenda of the Meeting of American Chiefs of State.

On February 26, 1967, during the Second Session of the Eleventh Meeting of Consultation, its President forwarded to the Secretary General of the Organization, Dr. José A. Mora, the following documents from that session: 2

D. THIRD SESSION

36. The Third Session of the Eleventh Meeting of Consultation of Ministers of Foreign Affairs was held in Punta del Este, Uruguay, April 8-14, 1967. However, prior to that Third Session, and as the Meeting of Consultation had decided in Resolution I/2, adopted at its previous session in Buenos Aires. Argentina, the Special Committee of Personal Representatives of the Chiefs of State met in Montevideo, Uruguay, March 13 through 24. This Special Committee worked on an informal and private basis, and prepared a two-part document: one part of a political-declarative nature (preamble) and the second of a descriptive-operational nature, wherein five of the seven points of the

agenda approved for the Meeting of American Chiefs of State were elaborated upon. The sixth item on the agenda, concerning military expenses, was submitted to the Third Session for consideration. 1

Members of the Meeting. During the Third Session of the Eleventh Meeting of Consultation, the accredited members were the Ministers, Secretaries of Foreign Affairs, Special Delegates and Counselors and Advisors that figure in the corresponding list of participants.

The Delegation of Bolivia was not present at the Third Session. 2/

The Secretary General of the Organization, Dr. José A. Mora, participated in the proceedings in accordance with Article 81 of the Charter.

Also participating in the Meeting was the Assistant Secretary General of the Organization, Dr. William Sanders.

On an observer basis, the United Nations was represented at the Meeting by an alternate for the Secretary-General, in accordance with Resolution XXXIX of the Ninth International Conference of American States.

- President of the Meeting. Pursuant to Article 8 of the Regulations of the Meeting of Consultation, the President of Uruguay designated the Minister of Foreign Affairs, Dr. Héctor Luisi, as provisional President dent; he was elected Permanent President at the first plenary session of the Third Session. A decision to that effect had been reached earlier, at the preliminary session.4
- Secretariat of the Meeting. The Government of Uruguay requested the Secretary General of the Organization of American States that, in view its of special responsibility for organizing and holding the meetings in Uruguay-the Meetings of the Special Committee of Presidential Representatives, the Third Session of the Eleventh Meeting of Consultation of Ministers of Foreign Affairs and the Meeting of American Chiefs of State--, he adopt the necessary measures to organize the Secretariat of those meetings

Thus, the Government of Uruguay did not exercise the right accorded to it under Article 10 of the Regulations, i.e., to designate the Secretary General for the Third Session of the Eleventh Meeting of Consultation.

- 40. Regulations of the Meeting. At the first plenary session of the Third Session, it was decided to ratify the Regulations of the Meeting of Consultation of Ministers of Foreign Affairs as approved by the Council of the Organization on March 1, 1951, with the addition of the transitory provision for the Eleventh Meeting of Consultation incorporated by the Council on January 24, 1967. 1
- Program. That plenary session also approved the decision adopted at the preliminary session to the effect that the purpose of the Third Session of the Eleventh Meeting of Consultation of Ministers of Foreign Affairs was to establish the agenda for the Meeting of American Chiefs of State, to which end the draft prepared by the Special Committee of Presidential Representatives that met in Montevideo would be considered.2/
- Invitations to the Meeting of American Chiefs of State. ratified at the first plenary session was the decision taken at the preliminary session to authorize the Secretary General of the Organization to extend invitations for the Meeting of American Chiefe of State 3/ to extend invitations for the Meeting of American Chiefs of State.
- 43. Sessions. During the Third Session of the Eleventh Meeting of Consultation of Ministers of Foreign Affairs, the following sessions were held: a preliminary session and three plenary sessions, the last of which was the closing session.

General Committee. At the first plenary session it was decided that the General Committee would study the agenda for the Third Session, which Committee would be made up of all the participating delegations. It would use the 1967 Program of Action for the Alliance for Progress as its

The General Committee met on April 9, 10 and 11, in private meetings. To accomplish its work, the Committee appointed three working groups intended to obviate the need for the reservations and declarations that had been made to the document prepared by the Special Committee of Presidential Representatives. The working groups were made up of the following delegations: Working Group I, composed of the delegations of Brazil, Chile, Colombia, El Salvador and the United States, was assigned topics I, II and III; Working Group II, composed of the delegations of Argentina, Ecuador, Panama, Peru and Mexico, was assigned the preamble, while Working Group III, composed of the delegations of Costa Rica, the Dominican Republic, Haiti, Paraguay and Venezuela, was assigned topics IV and V.

Topic VI, concerning military expenditures, was considered by the full General Committee.

- 44. Committee on Credentials. The decision was that the Committee on Credentials would be composed of the same delegations that had served on it during the first two sessions; in other words, it was composed of Gustemala, Mexico and Paraguay. 1
- 45. Coordinating and Drafting Committee. Correspondingly, it was decided that the Coordinating and Drafting Committee would also be made up of the same delegations that had served on it during the first two sessions: in other words, the delegations of Brazil, Colombia, Haiti and the United States, each representing one of the official languages of the Organization. 2/
- 46. Order of Precedence. The lots drawn at the preliminary session established the following order of precedence:

47. Decisions. The first plenary session ratified the decision adopted at the preliminary session to the effect that, because the session would be brief but very special in nature, the final act required under Article 28 of the Regulations would not be signed; instead, the Secretary General of the Organization would be authorized to publish, once the Eleventh Meeting of Consultation of Ministers of Foreign Affairs had ended, a collection of the documents from the three sessions, as well as a chronological account of the proceedings of the Eleventh Meeting of Consultation.

At the third plenary session, which was also the closing session of the Eleventh Meeting of Consultation of Ministers of Foreign Affairs, the Report of the Rapporteur of the General Committee was presented and its draft on the exposition of the agenda of the Reeting of American Chiefs of State was approved. Furthermore, having held the closing session at a time when the proceedings of the Meeting of American Chiefs of State had virtually come to a close, the content of what would become the summary minutes of that Presidential Meeting were discussed and approved. 2

48. Reservations, declarations and statements for the record. Because, as stated in paragraph 47, no final act would be signed, it was decided that the verbatim minutes of the closing session. would contain any reservations and declarations the delegations might wish to make. Thus, the delegations of Peru, Ecuador, Colombia, Mexico, Uruguay, Venezuela and the United States (in the order in which they were presented) requested that their declarations and reservations be introduced into the record. Further, the Latin American countries requested that the record also include a statement on the Chilean proposal on "tied" loans. The minutes for that closing session also included the text of the communication received from the Government of Bolivia and addressed to the President of the Eleventh Meeting of Consultation, explaining why its Delegation would not be present at the final stage of the Meeting, as well as the the reply sent by the President of the Meeting of Consultation. 4

DECISIONS TAKEN BY THE COUNCIL OF THE ORGANIZATION OF AMERICAN STATES IN CONNECTION WITH THE MEETING

ORAL REPORT PRESENTED BY DR. JOSE A. MORA, SECRETARY GENERAL OF THE OAS, IN CONNECTION WITH THE SPECIAL DECLARATION OF THE FOURTH ANNUAL MEETING OF CIES AT THE MINISTERIAL LEVEL

(Decision taken on June 27, 1966) $\frac{1}{2}$ /

The Council heard the following report of the Secretary General regarding the mandate entrusted to him by the Fourth Annual Meeting of the Inter-American Economic and Social Council at the Ministerial Level, which was to consult the governments of the member states on the advisability of holding a meeting of the Chiefs of State of the countries of the inter-American system, in order to give more effective political thrust to the objectives of the Alliance for Progress and to agree upon the most suitable means for hastening their accomplishment. It was decided that the Secretary General would communicate with the governments through their representatives on the Council of the Organization, in order to ascertain their points of view on this matter.

Text of the Oral Report Given by the Secretary General of the OAS2/

The SECRETARY GENERAL: This seems to be a fitting occasion to advise the Council of a mandate I received from the Fourth Annual Meeting of the Inter-American Economic and Social Council at the Ministerial Level. At its sixth plenary session, held on April 1 of this year, that Meeting approved the following "Declaration":

SPECIAL DECLARATION (1-M/66)

Bearing in mind the proposal presented by the Delegation of Argentina at the Fourth Annual Meeting of the IA-ECOSOC at the Ministerial Level, the Chiefs of Delegations thereto

AGREE:

To entrust the Secretary General of the OAS with the task of consulting the governments of the member states on the advisability of holding a meeting of the Chiefs of State of the countries of the Inter-American System, in order to give a more effective political thrust to the objectives of the Alliance for Progress and to agree upon the most suitable means for hastening their accomplishment.

Pursuant to this mandate, I had the honor to meet first with His Excellency the President of the Republic of Argentina, Dr. Illia, to ask his opinion and his ideas on this important initiative. President Illia told me of his lively interest in seeing this idea materialize, an idea that he said had come out of a joint declaration made during a meeting with the President of Chile, His Excellency Dr. Frei. The President of the Council of Government of Uruguay was also in agreement with the proposal. The view of the President of the United States was made public when, at a meeting in Mexico, he said that he would like to see this idea materialize. I also had occasion to visit with the President of Venezuela. Dr. Raúl Leoni, who also expressed his support of this initiative, adding that the meeting would have to be properly prepared, with preliminary agreement as to the agenda and, of course, its date and venue. On several occasions, the presidents of the Central American republics also expressed their intention to attend the proposed meeting. In general, the initiative seems to have been well received. Other presidents have also expressed opinions favoring the meeting. And at this point it seems to me that the best course of action to complete the consultations entrusted to the Secretary General would be through the representatives of the governments on the Council, with the understanding that the subject will prompt future talks among the American heads of

CONVOCATION OF THE ELEVENTH MEETING OF CONSULTATION OF MINISTERS OF FOREIGN AFFAIRS

(Resolution adopted on September 19, $1966)\frac{1}{2}$ /

WHEREAS:

The Inter-American Economic and Social Council, at its Fourth Annual Meeting at the Ministerial Level, held in Buenos Aires from March 25 to April 1, 1966, adopted a special declaration in which it was agreed: "To entrust the Secretary General of the OAS with the task of consulting the governments of the member states on the advisability of holding a meeting of the Chiefs of State of the countries of the inter-American system, in order to give a more effective political thrust to the objectives of the Alliance for Progress and to agree upon the most suitable means for hastening their accomplishment";

On June 27, 1966, the Secretary General of the Organization presented a report to the Council regarding the mandate that was entrusted to him in the said declaration, and the Council decided that the Secretary General should communicate with the governments, through the Representatives on the Council of the Organization, in order to ascertain their points of view regarding this proposal;

The replies of the governments of the member states to the Council's inquiry show the interest of the people of the hemisphere in a meeting at the highest level, to take decisions designed to facilitate economic and social development;

The economic and social problems of the hemisphere are of an urgent nature, because of the need to give greater effect to the aims of the Alliance for Progress, and of because the pressing need to further Latin American economic integration;

A meeting of Chiefs of State requires adequate preparation and the study of the various solutions that would make it possible to accomplish the purposes indicated;

Article 39 of the Charter of the Organization makes provisions for holding a Meeting of Consultation of Ministers of Foreign Affairs "in order to consider problems of an urgent nature and of common interest to the American States," in accordance with articles 40 to 42 of the Charter; and

Resolution XLVI of the Tenth Inter-American Conference, held in Caracas, empowered the Council of the Organization to "carry out studies and prepare drafts, whenever it deems this advisable, regarding topics on the agenda of the Inter-American Conference or the Meeting of Consultation of Ministers of Foreign Affairs,"

THE COUNCIL OF THE ORGANIZATION OF AMERICAN STATES

RESOLVES:

- 1. To convoke the Eleventh Meeting of Consultation of Ministers of Foreign Affairs of the member states of the Organization, in accordance with Article 39 of the Charter, in order to take decisions regarding a meeting of Chiefs of State for the purpose of strengthening the Alliance for Progress and of agreeing upon new measures for hemispheric cooperation to facilitate Latin American economic integration.
- 2. To hold the Meeting of Consultation convoked by virtue of the preceding paragraph at the Pan American Union, within a period not exceeding 90 days from the date of this resolution.
- 3. To establish a Committee on Preparations for the Eleventh Meeting of Consultation, which shall be composed of the delegations of the member states accredited to the Council. This Committee, taking into account the purposes of the Meeting of Chiefs of State, the proposals that the governments may present in this connection, and the technical opinions referred to in paragraph 4, shall prepare studies and pertinent preliminary proposals.

4. To invite the highest-ranking officials of intergovernmental organizations and agencies whose activities are related to the subjects to be discussed to give their valuable technical advise, individually or collectively, to the Committee on Preparations for the Eleventh Meeting of Consultation of Ministers of Foreign Affairs. The Council shall extend the corresponding invitations as soon as the Committee on Preparations has begun its work.

The Committee on Preparations, on behalf of the Council, may invite other distinguished individuals of the hemisphere to express their views on specific problems related to the studies and preliminary proposals the Committee is to prepare.
