


- The figures show the distribution of the modified appropiation as of December 31, 2015.

Funds Received by the IACHR in 2015 Distributed by Source of Funding (in thousands of USD)





IACHR Execution by Source of Funding - 2015 (in thousands of USD)





IACHR Execution by Object of Expenditure - 2015 (in thousands of USD)




