OBJECTIVES AND EXPECTED OUTPUTS OF THE IABIN COUNCIL MEETING

Meeting Dates:	May 9 – 11, 2007
Place:	Punta del Este, Uruguay

I. Introduction

In accordance with the IABIN Rules of Procedure, the Chairperson of the IABIN Council, after consultation with Council Members and with the support of the IABIN Secretariat and the Organization of American States, has convened the members of the Council to conduct the Fifth IABIN Council Meeting. The meeting is scheduled for 9-11 May, 2007 in Punta del Este, Uruguay.

The local organization of the meeting has been handled by the Uruguayan Focal Point, Dr. Ana Aber with the support of the government of Uruguay and the GS/OAS country office there. The Council recognizes these efforts and is very grateful to both Dr. Aber and her team at the National Environment Directorate (DINAMA) of the Ministry of Public Housing, Land Administration, and Environment of Uruguay and the GS/OAS.

IABIN is entering the third year of the execution of the Global Biodiversity Facility (GEF) sponsored project. The objective of the 5th IABIN Council Meeting is to evaluate progress and goal achievement. The meeting will review project progress and provide guidance by the Council to the project implementing agency (World Bank), Executing Agency (GS/OAS) and the IABIN Secretariat. It is expected that aspects considered during the Council meeting will translate into a call for action and specific guidance to all IABIN Council and participating countries.

The Council will review, and, if appropriate, formally adopt a number of proposed IABIN standards and applications. Equally important is to revisit the IABIN vision, particularly its future and sustainability after the GEF project ends. Here a strategic analysis is called for to define the areas where IABIN should further concentrate and where it can (i) carve a niche within the biodiversity informatics community; (ii) increase its usefulness to users; and (iii) support decision making processes throughout the Hemisphere. This goes hand in hand with the identification of the minimum resources needed to fulfill the vision and the fundraising activities that would need to be carried out.

This document complements the Fifth IABIN Council Meeting Agenda previously distributed (Annex 1).
