




5 pieces of seized real state were handed in to CODENA and used as places where citizens returning home could spend quarantine period thus avoiding propagation of COVID-19
































OPERATION BERILO - ADMINISTRATIVE PROCEDURE (VEHICLES HANDED IN TEMPORARILY)

- Two hotels rented to Mr. Julio Pereira.
- One piece of property handed in to the National Police Department against Organized Crime.
- One piece of property handed in to the National Police Department of Homicides.
- One piece of property handed in to the National Police Anti-kidnapping Department.
- Five pieces of property (hotels) handed in to Codena Ministry of Public Health.
- Four vechicles sold at National Public Auction.
- Seven vehicles handed for provisional use to the National Anti-narcotics Secretariat, National Polical and Dinac.
- Remaining vehicles stored in Senabico for custody.
- Remaining real state is being considered for rent or support to other institutions of the Paraguayan State.
- All confiscated and handed money has been audited and entered into the banking system.
