Francisco Álvarez De Soto

His Excellency Francisco Alvarez De Soto is the Minister of Foreign Affairs of the Government of Panama. He has previously served in the public sector as Special Ambassador for Trade and Deputy Adviser for the Vice minister of Foreign Trade and for the Minister of Commerce and Industry (1999-2001); Ambassador and Managing Director for International Economic Relations (2001-2002); Deputy Presidential Commissioner to the Puebla-Panama



Plan (2002-2003); Secretary General of Foreign Affairs (2003); Principal Member of the Council on Foreign Relations (2003-2004); Vice minister of International Trade Negotiations (2009-2010); Vice Counselor of the Republic and, subsequently, Counselor of the Republic (2011-2013).

Mr. Alvarez has been awarded the National Orders of Vasco Núñez de Balboa, Manuel Amador Guerrero, Belisario Porras and the Order of the Central American Integration System (SICA). In September 2013, H. M. Juan Carlos I, King of Spain, awarded him the title of Commander of the Royal Order of Isabel the Catholic. Since 2008, Mr. Alvarez is Knight of Magisterial Grace of the Sovereign Order of Saint John of Jerusalem, of Rhodes and of Malta (Order of Malta), and in 2013 was appointed Panama's Representative to the roster of experts of the Dispute Settlement Body (DSB) of the World Trade Organization (WTO).

Mrs. Amorim is the Secretary for Public Management of the Ministry of Planning, Budget and Public Administration of the Government of Brazil. 



Kevin Casas-Zamora



Sylvia Cesaratto



Luis Petrikorena Arbelaiz


