Dear Dr. Ochoa,

In reference to the Memorandum of Understanding dated September 12th, 2019 (MOU) between the General Secretariat of American States (GS/OAS) and the Regents of the University of California on behalf of its Riverside campus (UCR), where the two institutions [the Parties] agreed to cooperate in the promotion of innovation and entrepreneurship as a critical tool to advance sustainable and inclusive economic and social development in the Latin American and Caribbean Member States of the Organization of American States (OAS), the GS/OAS would like to undertake the following activities with UCR:

1. Collaborate in the delivery of training as follow up to the program HUB of Commercialization and Transfer of Technology (HUB) of the OAS Inter-American Committee of Science and Technology (COMCYT) held in Barranquilla, Colombia from November 14-16, 2019. UCR will provide technical and analytical support, including two modules (6 hours) of presentations (in ppt format) to share with the participants of the HUB who received support to review the technologies presented in the HUB program. The presentations by two UCR experts will cover key elements of evaluation of technologies, technology-based entrepreneurship strategies, case studies with HUB teams, tools for commercialization, transfer, licensing, marketing and spin out technologies.

The GS/OAS will provide the amount of USD \$5,000 (Five thousand dollars) to compensate UCR for their aforementioned contribution.

2. UCR will provide virtual knowledge sharing, training and mentoring for HUB participants and partners. The HUB online mentoring will be jointly supported by UCR with the team of the OAS COMCYT Technical Secretariat and the HUB Coordinating Committee. The UCR and GS/OAS team will update and revise the key components of the mentoring services to be provided and determine the specific terms of access based on the results of test trials and feedback from early virtual mentoring HUB users, including a report from UCR with recommendations for the deployment and operation of this new component of the HUB program.

The GS/OAS, will provide the amount of USD 10,000 (Ten thousand dollars) to compensate UCR for their aforementioned contribution which will cover the start and the first 3 months of the online mentoring program for the HUB.

Upon signature of this letter by the Parties, the GS/OAS will transfer to UCR the total amount of \$15,000 (Fifteen thousand dollars) to cover the activities described above.

The transfer will be carried out via wire transfer to the general holding account of the UCR to further credit to the Office of Technology Partnerships as indicated below:
