#### STANDARDIZED TEMPLATES FOR NEW WORK ITEMS AND LIAISON STATEMENTS

The XXV Meeting of the Permanent Executive Committee of CITEL, COM/CITEL,

#### TAKING INTO ACCOUNT:

That one activity at COM/CITEL meetings is the generation of liaisons from within Working Groups regarding the work carried out and the results thereof, with a view to their subsequent presentation for approval at plenary meetings,

#### **WHEREAS:**

- a) At the XVII Meeting of PCC.I reporting guidelines were approved for Working Groups and Rapporteurships, which standardized the structure and content of their reports and allowed a clearer evaluation of activities carried out, objectives attained, and future prospects;
- b) At the XIX Meeting of PCC.I a template for Liaison Statements was approved to streamline communications with different organizations in a clear, concise and objective fashion,

#### **RECOGNIZING:**

That implementation of standard templates for liaison statements for use in all COM/CITEL meetings would allow standardization of the structure of information to be provided, help ensure necessary information is provided and facilitate the approval process,

- Identify the Working Group(s) and Rapporteurship(s) (*if known*) or other standards organizations to which it has been sent. (*A liaison statement can be sent to more than one organization.*)
- Indicate if the liaison statement is sent for action *or* comment *or* information. (*If sent to more than one organization, indicate this for each one.*)
- Indicate the level of approval, e.g. Committee, or Working Group, or Rapporteurship, or state that the liaison statement has been agreed at a Rapporteurship meeting.

- If action is requested, indicate the date by which a reply is required.
- Include the name, address and international telephone number of the contact person(s).
- The text of the liaison statement should be concise and clear, using a minimum of jargon.
- Liaison statements should be forwarded to the appropriate destinations as soon after the meeting as possible. Copies of all liaison statements should also be sent to the chairmen of the Working Group(s) and Rapporteurship(s) involved for information.

#### SUBMISSION OF WCIT IAPS TO ITU COUNCIL WORKING GROUP ON WCIT-12

#### **RECOGNIZING:**

- a) Resolution COM/CITEL RES. 226 (XXI-09) "Guidelines for the adoption of Inter-American Proposals";
- b) Resolution PCC.I/RES. 190 (XIX-11) "Submission of Inter-American Proposals to the World Telecommunication Standardization Assembly (WTSA) and the World Conference on International Telecommunications (WCIT)",

#### **CONSIDERING:**

- a) That CITEL Inter-American Proposals (IAPs) for all ITU conferences are increasingly important in many cases as important as national positions;
- b) That CITEL IAPs have played a crucial role in ITU assemblies, especially at WTSA-08;

#### ADOPTION OF THE CITEL PROGRAM OF COURSES FOR 2012

The XXV Meeting of the Permanent Executive Committee of CITEL, COM/CITEL,

#### **CONSIDERING:**

- a) The report of the Coordination Center for the Development of Human Resources on the results of the training program of CITEL for 2011;
- b) That a fundamental need exists to update on an ongoing basis the training of telecommunication/information and communication technology (ICT) personnel, taking into account the dynamic environment of the sector;
- c) That the results of the survey of training needs presented by the Member States of CITEL for 2012 are now available;
- d) That the budgetary allocation for scholarships in the OAS Regular Fund has been reduced for 2012;
- e) That LACNIC and ISOC have offered to impart, in 2012, with high-level experts, virtual sessions and virtual clinics on Internet-related subjects of high importance, at no cost to CITEL,

#### **RECOGNIZING:**

That through the CITEL Regional Training Centers, with cooperation from the Center of Excellence for the Americas Region of the International Telecommunication Union (ITU), effective training on telecommunications/ICT may be provided,

#### **RESOLVES:**

- 1. To approve the preliminary CITEL program of courses for 2012, attached hereto as an Annex, prepared taking into account the priority training needs presented by the Member States.
- 2. To authorize the Coordination Center to select other courses meeting the training needs of the Member States; to schedule the dates for the courses; and to decide the number of scholarships to be awarded in each case, up to the maximum amount of the budgetary allocation available to CITEL and in accordance with the training needs and priorities of the Administrations.
- 3. To establish that in the event the Department of Human Resources of the Organization of American States (OAS) issues an invitation to participate in the competition for the Professional Development Scholarships Program for 2013, the Coordination Center would participate in cases where the Institutes are interested in sharing the costs corresponding to scholarships.

- 4. To authorize the Coordination Center to reallocate, insofar as possible, the amounts allocated for scholarships in the event evaluation materials are not available and the draft invitation at least five months prior to the start of the course programmed.
- 5. To thank the Department of Human Resources of the OAS for the ongoing and excellent support provided in disseminating the course offerings of CITEL and to emphasize the importance for the Member States of having training programs that continue to address the specific subject of telecommunications/information and communication technologies, and their recognized contribution to sustainable development and poverty reduction, and that this training be accorded the highest priority.
- 6. To thank the Center of Excellence for the Americas Region of the International Telecommunication Union (ITU) for all support and collaboration it provides to CITEL in the holding of the courses.
- 7. To thank Latin American and Caribbean Internet Addresses Registry (LACNIC) for offering the use of its IPv6 Laboratory at no cost, which will constitute a highly important supplement to the training generally offered through CITEL in this area.
- 8. To thank LACNIC and Internet Society (ISOC) for their offer to impart without cost to CITEL virtual sessions/virtual clinics on matters related to the Internet in the region.
- 9. To establish the following conditions on which the courses will be offered, unless otherwise indicated in *resolves* 1:
- The maximum number of students in each online course group will be: 35 participants.
- The maximum registration fee for all online courses with a scholarship through CITEL will be US\$200.
- That 10% of the total amount collected as registration fees from participants receiving scholarships from CITEL/OAS for online courses imparted utilizing the platform of the ITU Center of Excellence will be deposited in an account to be utilized as reserve (seed) fund budget for the program of courses for coming years, whose use would be authorized through the Coordination Center for the Development of Human Resources.
- 10. To urge the Administrations to present candidates for scholarships to be offered for the 2012 program of courses indicated in *resolves* 1 so as not to miss opportunities made available to them, in accordance with the priorities they have duly forwarded to the Secretariat of CITEL.

#### TO INSTRUCT THE EXECUTIVE SECRETARY:

- 1. To send a note to the Director of the Telecommunication Development Bureau of the International Telecommunication Union (ITU) expressing appreciation for and emphasizing the important coordination effort being made with the ITU Regional Office for the Americas and the Caribbean through the Center of Excellence for the Americas Region, which has enabled high-level courses to be imparted jointly in response to the priority and requests of the region. This note would request that the Regional Office continue to receive the financial and human resources needed to continue the successful efforts made thus far in the Americas by the two entities.
- 2. To send a note thanking LACNIC for offering the use of its IPv6 Laboratory to the Member States at no cost.

- 3. To send a note expressing appreciation to LACNIC and ISOC for the innovative possibility of providing virtual sessions/virtual clinics at no cost to CITEL.
- 4. To provide support to the Coordination Center for the Development of Human Resources as required.
- 5. To disseminate these courses as widely as possible.

## REGIONAL BROADBAND FORUM IN SUPPORT TO THE ORGANIZATION OF THE CONNECT AMERICAS SUMMIT

The XXV Meeting of the Permanent Executive Committee of CITEL, COM/CITEL,

#### **CONSIDERING:**

- a) That the Connect Americas Summit will be held from July 17 to 19, 2012, in Panama City, Panama. It is one of five regional Summits organized by the International Telecommunication Union (ITU) as part of the Connect the World initiative;
- b) That the objective of that initiative is to mobilize human, financial, and technical resources to implement the outcomes of the two phases of the World Summit on the Information Society (WSIS) and regional initiatives adopted by the Member States at the 2010 World Telecommunication Development Conference (WTDC);
- c) That one of the regional initiatives for the Americas agreed in the Hyderabad Action Plan is broadband access in urban and rural areas; and
- d) That the Strategic Plan of CITEL for 2010-2014 establishes among its strategic goals to promote and coordinate activities, initiatives, projects, and programs of interest to the region related to the development of telecommunications/ICTs; and to step up cooperation and coordination with the International Telecommunication Union (ITU) and other organizations in order to optimize the use of scarce human and financial resources,

#### **BEARING IN MIND:**

That the Meeting of Organizations and/or Agencies to Promote Telecommunications/ICT Development, held in the framework of the XIX Meeting of Permanent Consultative Committee I: Telecommunications/ICT, identified possible strategic partners in the area of connectivity and access for the implementation of the important regional initiative,

#### **RESOLVES:**

- 1. To hold a Broadband Forum on April, 2012, in Mexico City, Mexico in order to develop a regional assessment of the needs of the region in the area of connectivity and access, with the aim of better results of the Connect Americas 2012.
- 2. To establish an Ad Hoc Group to prepare the Broadband Forum, with participation by representatives of the four subregions of the Americas: North America, Central America, South America, and the Caribbean.

#### **INSTRUCTS:**

- 1. The Executive Secretary:
  - a. To provide the support necessary for the holding of the Forum and its preparations.
  - b. To send a circular letter to Member states in order to identify, as soon as possible, the focal points of each sub-region that will compose the Ad Hoc Group to prepare the Broadband Forum.
- 2. The Ad Hoc Group, in coordination with the Secretariat and the host country, based on the actions and objectives set forth in the description of the proposal, to carry out the preparations for the Forum.

## **COM/CITEL RES. 242 (XXV-11)** <sup>7</sup>

#### CONTRIBUTION BY CITEL TO THE SIXTH SUMMIT OF THE AMERICAS

The XXV Meeting of the Permanent Executive Committee of CITEL, COM/CITEL,

#### **CONSIDERING:**

- a) That on April 14 and 15, 2012, the 34 Heads of State and Government of the Americas will meet in Cartagena, Colombia for the Sixth Summit of the Americas, whose theme will be "Connecting the Americas: Partners for Prosperity";
- b) That the Sixth Summit of the Americas will focus on the role of physical integration and regional cooperation as a means to overcome the Hemisphere's challenges and to achieve greater levels of development through consideration of the sub-themes: poverty and inequity, citizen security, natural disasters, and access to technology; and
- c) That the Inter-American Telecommunication Commission (CITEL) has addressed in a crosscutting manner the sub-themes to be considered at the Sixth Summit of the Americas and that it is important for discussions of these issues to reflect clearly the importance of telecommunications and information technologies,

#### **BEARING IN MIND:**

- a) That in the Declaration of Mexico, the Representatives of the telecommunication administrations of the Organization of American States (OAS), at the Fifth Regular Meeting of the Assembly of CITEL, agreed to continue fulfilling the telecommunication-related commitments assumed at the Summits of the Americas, and to promote and disseminate the implementation of the recommendations and guidelines of CITEL; and
- b) That objective 3 of the Strategic Plan of CITEL establishes the mandate [t]o identify and recommend options to address problems of the existing digital divide among and within the Member States, in keeping with the mandates of the Summits of the Americas,

#### **RESOLVES:**

1. To invite the Member States of CITEL to forward to their National Coordinator of the Sixth Summit of the Americas the following documents arising from different meetings of CITEL, in order to reflect the positive impact of telecommunications and information and communication technologies on poverty and inequity, citizen security, natural disasters, and access to technology:

The Declaration of Mexico of the Fifth Meeting of the Assembly of CITEL

To request the Chairman of COM/CITEL to invite the PCCs to consider the development of procedures which provide processes for Rapporteurs' meetings which include:

- advance notification of meetings, specifically that:
  - normal and interim Rapporteur meetings should be approved in advance at a committee meeting;
  - extraordinary Rapporteur Meetings should be scheduled such that notifications can be issued at least 3 months in advance of these meetings;
- methods of reporting progress;
- a requirement to allow for open participation.

The reasons follow below:

- a) That Article 2 of the Regulations of the Inter-American Telecommunication Commission makes provision for the CITEL Assembly, the Permanent Executive Committee (COM/CITEL), and the Permanent Consultative Committees each which may include the use of Rapporteurs;
- b) That Article 38 indicates that no plenary, committee, subcommittee, ad hoc group, or working group session shall be held unless the place and time have been announced to participants sufficiently in advance to permit them to attend;
- c) That Article 71 indicates that at each installation session, COM/CITEL shall prepare its work program for the intervening period until its next meeting, and shall set the date and place for its meetings. Further that COM/CITEL may establish technical committees, subcommittees, working groups and Ad Hoc Groups, joint working groups and Rapporteurs to perform its functions;
- d) That Article 83 indicates that each PCC may establish working groups and Ad Hoc Groups in accordance with Article 96:
- e) That Article 96 provides Working Procedures governing the activities of the PCCs including Ad Hoc Groups and that both the CITEL Assembly and COM/CITEL may apply the Article 96 procedures or any part thereof in establishing their Working Groups or Ad Hoc Groups;
- f) The Regulations of the Inter-American Telecommunication Commission (CITEL) are silent with regards to Rapporteur meetings;

To instruct CITEL to remain a forum for dialogue, coordination, and cooperation in the telecommunication area in the Hemisphere and to maintain a high level in providing technical assistance and capacity-building in the Member States, as appropriate and in accordance with the Plan of Operations for 2012, which includes activities in the following areas: preparation of inter-American proposals for the World Radiocommunication Conference, the World Telecommunication Standardization Assembly, and the World Conference on International Telecommunications of the International Telecommunication Union; promotion and development of and debate on new services and technologies; and coordination, planning, and consensus-building among the Member States with regard to tariff and economic matters and harmonization of radio spectrum use, taking special account of the need to prevent and avoid harmful interference, and of protection against the electromagnetic non-ionizing emissions.
- 3. To encourage the promotion of nondiscriminatory access to telecommunication/ICT media, services, and applications, including applied research with a view to meeting the demand for modern telecommunication/ICT services and applications.
- 4. To instruct the General Secretariat of the OAS to continue to provide the Secretariat of CITEL, within the resources allocated in the program-budget of the Organization of American States (OAS) and other resources, human and financial resources, as well as the support necessary to ensure continuity in the implementation of its mandates.

5. To instruct CITEL to continue conducting, organizing, or sponsoring the studies necessary to highlight the contribution of ICTs and their applications in integral development.
