PCC.I/RES. 306 (XXXVI-20)²

APPROVAL OF INTER-AMERICAN PROPOSALS (IAPs) BY ELECTRONIC MEANS

The 36 Meeting of the Permanent Consultative Committee I: Telecommunications/Information and Communication Technologies (PCC.I)

CONSIDERING:

- a) The need to cancel the 36th physical meeting of PCC.I in light of the increased health risks associated with the COVID-19
- b) That Article 78/3 of the CITEL Regulations establishes that the PCCs may approve resolutions, decisions or recommendations by electronic means, provided there are no negative responses by Member States of CITEL, and applying the procedures that may be established by COM/CITEL.
- c) That Article 85/11 of the CITEL Regulations establishes that the PCCs are entitled to modify their working methods and adapt them to the needs of their members in the most efficient manner possible, provided they do not contravene the provisions of the Statute and Regulations of CITEL.
- d) That there are no provisions in the Statute or in the Regulations of CITEL that prohibit the PCCs from adopting Inter-American Proposals (IAPs) by electronic means.

RESOLVES:

- 1. To hold the 36 Meeting of CCP.I virtually.
- 2. To authorize the approval of Inter-American Proposals (IAP) by electronic methods at the 36 Meeting of CCP.I.
- 3. To approve the holding of the necessary virtual plenary sessions, until June 30, 2020, in order to achieve the purpose of the 36 Meeting of CCP.I. The notice of convocation to those sessions shall be transmitted to the participants two (2) weeks in advance.
- 4. To order that the working procedures adopted by this resolution for the 36 Meeting of CCP.I be applied to the coming meeting(s) of CCP.I should the conditions and health treats due to the Coronavirus (COVID-19) outbreak persist.

PCC.I/RES. 307 (XXXVI-20)³

AGENDA, SITE, AND DATE OF THE 37 MEETING OF PCC.I

The 36 Meeting of Permanent Consultative Committee I: Telecommunications/Information and Communication Technologies (PCC.I),

CONSIDERING:

- 1. That, because of the global Cronovirus-19 (COVID-19) pandemic and current restrictions set by health authorities in our region's member states, social distancing must continue as a measure to contain the spread of the virus and that health conditions and threats persist;
- 2. That the host country of the World Telecommunications Standardization Assembly (WTSA-20), during virtual consultations with ITU advisors, proposed changing the date to hold the activity from February 23 to March 5, 2021, in Hyderabad, India, given the current issues with this global pandemic;
- 3. That ITU will send consultations via correspondence to the Member States, taking into account that the urgency to make this decision to change the date of the WTSA-20, in accordance with the provisions stated in the Convention and General Regulations;
- 4. That CITEL has scheduled the 37 Meeting of Permanent Consultative Committee I: Telecommunications/Information and Communication Technologies from August 17 to 21, 2020, to be carried out by means of virtual sessions;
- 5. That the Working Group for the Preparation and Follow-up of the WTSA, WCIT and WTDC (WGCONF) will hold the *final meeting* within the framework of the 37 Meeting of PCC.I;
- 6. That, given this new scenario, it is advisable to adjust the times for CITEL's preparatory work for the WTSA-20, taking into account the new proposed dates,

RESOLVES:

- 1. To hold the 37 Meeting of Permanent Consultative Committee I: Telecommunications / Information and Communication Technologies via videoconferencing, exceptionally by virtual means, from October 26 to 30, 2020.
- 2. To thank the Administration of Colombia for continuing to host this meeting using online videoconferencing and for providing the resources needed to hold that meeting.
- 3. To instruct the Secretariat of CITEL to perform the necessary coordination tasks together with the Chair of PCC.I and the host country with respect to the change in the date, and, if there were any conflicts with this newly established date, to take the corresponding actions to select a new date and notify the CITEL membership before August 30, 2020.

- 4. To instruct the chairs of the working groups and their rapporteurs to continue their work using online platforms, focusing on the issues of interest and moving forward with the activities scheduled in their work plans to prepare for the 37 Virtual Meeting of PCC.I, in close coordination with the chair of PCC.I and the CITEL Secretariat.
- 5. To instruct the CITEL Secretariat to ensure the necessary coordination to support the work of the working groups and rapporteurships using online platforms.
- 6. To instruct the Secretariat of CITEL to carry out the necessary coordination tasks to support the preparatory work of CITEL for the WTSA-20, in close coordination with the Chair of the Working Group and the Chair of PCC.I.
- 7. To adopt the Draft Agenda for the 37 Meeting of PCC.I, attached as an annex to the present Resolution.
