#### **COURSE PROGRAM OF CITEL FOR THE YEAR 2023**

The 40 Meeting of the Permanent Executive Committee of CITEL, COM/CITEL,

#### **CONSIDERING:**

- a. The Manual of Procedures for the Scholarship and Training Programs of the Organization of American States;
- b. That, in the framework of the Professional Development Program for 2023, the Regional Training Centers of CITEL shall be submitting proposals for courses during the first quarter of 2023; and
- c. That the results of the Competition of the OAS Professional Development Scholarship Program are not as yet available, nor is there any information about the budget available for scholarships in 2023,

#### **ACKNOWLEDGING:**

That, through the Regional Training Centers of CITEL and the Academy Training Centers of the International Telecommunication Union (ITU), effective training on telecommunications/ICT is enabled,

#### **RESOLVES:**

- 1. To empower CITEL's Coordination Center for the Development of Human Resources, in coordination with the CITEL Secretariat, to: (a) select, on the basis of the budget available for scholarships, the higher training priority courses of the member states; (b) schedule the dates for the courses to comply with the rules of the Department of Human Development, Education, and Employment of the General Secretariat of the OAS; and c) to increase or re-allocate the amounts of the scholarships provided.
- 2. To establish that, when the Department of Human Development, Education, and Employment of the General Secretariat of the OAS invites applications to the OAS Professional Development Scholarship Program for 2023, CITEL's Coordination Center shall participate in those cases where the institutes are interested in sharing the costs pertaining to the scholarships in accordance with the conditions of the OAS.
- 3. To hold virtual sessions on topical issues of telecommunications/information and communication technologies (ICT).
- 4. To urge the Administrations to submit applicants for the scholarships that shall be offered for the program of courses for 2023 in order to take advantage of the opportunities being provided.

- 5. To thank the Department of Human Development, Education, and Employment of the General Secretariat of the OAS for the continued and outstanding support provided for the dissemination of CITEL courses and to urge it to give the utmost priority to scholarships that are granted in coordination with the CITEL Secretariat, taking into account that telecommunications/information and communication technologies (ICT) have been recognized as supporting the integral and sustainable development of the Americas, under the principles of universality, equity, and affordability.
- 6. To thank the "ITU Regional Office for the Americas, which through the Academy Training Centers of the International Telecommunication Union (ITU) and the ITU Academy has substantially built up its cooperation with the CITEL Secretariat, awarding scholarships for the female leadership course to representatives of the telecommunications and ICT sector of CITEL member states, and continuing joint efforts to increase the courses and scholarships offered for the Americas region in 2023.
- 7. To thank "*CCATLAT*" for granting scholarships through the series of monthly virtual seminars. In addition to continuing its strengthening and joint work for capacity building and career development on current topics that are relevant for the members of CITEL.
- 8. To thank "CITIC-Ecuador" for granting scholarships through short seminars and for continuing to implement joint capacity-building activities in the region through the commitments taken on in the 2030 ICT Alliance and the Rural Women's Alliance, making it possible to continue offering updating talks on topics of interest for the region.
- 9. To thank the "CULLEN International" for granting scholarships to the courses on "EU proposal to regulate online platforms: digital markets act (DMA) and digital services act (DSA)" for career development and continuing to promote this kind of training and key knowledge generation on strategic topics for the region.
  - 10. To instruct the Executive Secretary of CITEL:
  - a. To support, as required, CITEL's Coordination Center for the Development of Human Resources.
  - b. To disseminate these courses as widely as possible, including via CITEL's website.
  - c. To develop, with CITEL's Regional Training Centers, the schedule of training activities on telecommunications/ICT, in the first quarter of 2023, in accordance with the priorities of CITEL's Permanent Consultative Committees, in order to meet the region's needs. The Executive Secretary is especially instructed to seek synergies and the development of courses to promote broader participation and with focus on youth, women, and countries of Central America and the Caribbean.

# RECOMMENDATION TO THE SECRETARY GENERAL OF THE OAS FOR THE RENEWAL OF THE APPOINTMENT OF THE CURRENT EXECUTIVE SECRETARY OF CITEL

The 40 Meeting of the Permanent Executive Committee of CITEL, COM/CITEL,

#### **CONSIDERING:**

- a) That the post of Executive Secretary is of critical importance for the functioning of CITEL;
- b) That the current contract of the Executive Secretary of CITEL with the General Secretariat of the OAS expires on September 21st, 2023;
- c) That article 17 of the CITEL Statute established the role of COM/CITEL regarding the selection process of the Executive Secretary of CITEL, becoming responsible, among others, of defining the profile, as well as the selection criteria of the candidate to occupy such position;
- d) That the Secretary General of the Organization of American States (OAS), taking into consideration the three candidates proposed by COM/CITEL in the year 2015, and in accordance with the General Standards to Govern the General Secretariat of the OAS, decided to appoint Oscar Giovanni León Suárez as Executive Secretary of CITEL;

#### TAKING INTO CONSIDERATION:

- a) That COM/CITEL considers management continuity as important, as well as the initiatives developed over the last four years by the current Executive Secretary.
- b) That the knowledge, experience and management skills of the current Executive Secretary have led to an improvement in the work of the CITEL Secretariat and all the Committees;

#### WHEREAS:

a) That the projects presented by the current Executive Secretary and adopted by the COM/CITEL, as for example the 2030 ICT Alliance for the Americas, signed on June 14th, 2016 in the Dominica Republic by Information and Communication Technologies (ICTs) companies and the General Secretariat of the OAS with goals for the year 2030, technical support for the implementation of the 21 guidelines for connectivity in rural or unserved areas, require continuity and adequate knowledge thereof so as to ensure the achievement of the goals set;

#### **RESOLVES:**

To kindly request the Secretary General of the OAS, taking into account the provisions of this Resolution, to consider the renewal of the Contract to the current Executive Secretary of CITEL for a period of five years.

# ESTABLISHMENT OF A WORKING GROUP ON GENDER EQUALITY AND MEANINGFUL YOUTH EMPOWERMENT

The 40 Meeting of the Permanent Executive Committee of CITEL, COM/CITEL,

#### **RECOGNIZING:**

- a) the fundamental values and principles of the Member States of CITEL and its role in supporting democracy, human rights, security and development as key priorities of the Organization of American States (OAS);
- b) CITEL's unwavering support for Gender Equality and Meaningful Youth Empowerment, inclusive of all women, girls, men and boys, of vulnerable and marginalized groups, of aboriginal and indigenous communities, and of people with disabilities and people with special needs;
- c) the fact that the United Nations Secretary-General has put "listen to and work with youth" and "place women and girls at the centre" as two of the 12 commitments in his 2021 report entitled "Our Common Agenda" towards the acceleration of the Sustainable Development Goals (SDGs);

#### STRUCTURE OF THE PERMANENT EXECUTIVE COMMITTEE (COM/CITEL)

The Permanent Executive Committee (COM/CITEL) is the executive organ of CITEL. It is composed of representatives of thirteen Member States elected at the CITEL Assembly, who shall serve until next Regular Meeting of the Assembly. The COM/CITEL was composed with the Administrations of the countries listed below, elected by the Eight Regular Meeting of the Assembly of CITEL for the period 2022-2026: Argentina, Bahamas, Brazil, Canada, Dominican Republic, El Salvador, Mexico, Paraguay, Peru, United States of America, and Uruguay, together with Colombia as Chair of COM/CITEL and Costa Rica as Vice-chair and the site of the Nineth Regular Meeting of the Assembly of CITEL<sup>10</sup>.

#### Functions<sup>11</sup>:

The following are the functions of COM/CITEL:

- 1. To implement the decisions of the CITEL Assembly, taking into account the recommendations of the General Assembly of the Organization and the mandates from the Summit of the Americas as they relate to telecommunications/ICTs.
- 2. To implement and enforce the objectives of Article 3 hereof.
- 3. To set the dates for both Regular and Special Meetings of the CITEL Assembly and the venue for the Special Meetings of the CITEL Assembly, and to change either or both as necessary.

- 5. To propose to the CITEL Assembly any amendments it may consider necessary to introduce to this Statute and the Regulations.
- 6. To establish a work program for the Secretariat and the Chair of COM/CITEL to implement the decisions of the CITEL Assembly.
- 7. To adopt any urgent measures that cannot be deferred until the following meeting of the CITEL Assembly, which shall remain in force until the CITEL Assembly can consider them.
- 8. Through its Chair or some other designated member of COM/CITEL, to represent CITEL at world, regional, or national meetings or conferences on telecommunications/ICTs or related activities.
- 9. With the cooperation of the Secretariat, to prepare studies, drafts of inter-American conventions and treaties, and any other documents relating to telecommunications/ICTs within the hemisphere.
- 10. To submit to the General Assembly an annual report on the activities of CITEL through the Secretary General and the appropriate Council of the Organization.
- 11. To establish such technical committees and working groups as it may deem necessary, determining their work programs.
- 12. Within the framework of CITEL's objectives, to plan and coordinate inter-American activities in the field of telecommunications/ICTs.
- 13. To review and approve a work program based on the program/budget approved by the General Assembly and an annual proposed budget for CITEL in pursuance of the provisions of Article 112 (c) of the Charter of the Organization, ensuring the strictest possible economy and mindful of the obligation upon CITEL to achieve satisfactory results from the work programs undertaken.
- 14. To approve the annual training plan and oversee its implementation.
- 15. To ensure fulfillment of the Strategic Plan adopted by the Assembly.

#### DRAFT RESOLUTION OF THE OAS GENERAL ASSEMBLY

FORWARDING THE DRAFT RESOLUTION TO THE OAS GENERAL ASSEMBLY "THE KEY ROLE OF THE INTER-AMERICAN TELECOMMUNICATION COMMISSION (CITEL) IN ADVANCING TELECOMMUNICATIONS/INFORMATION AND COMMUNICATION TECHNOLOGIES"

THE GENERAL ASSEMBLY.

#### **RECALLING:**

Resolution AG/RES. 2987 (LII-O/22), "The Key Role of the Organization of American States in Advancing Telecommunications/Information and Communication Technologies through the Inter-American Telecommunication Commission," adopted on October 6, 2022; and,

Resolution AG/RES. 2985 (LII-O/22), "Program-Budget of the Organization for 2023," adopted on October 6, 2022, as regards the mandates relating to CITEL;

NOTING resolution CITEL/RES. 80 (VII-18), "Strengthening CITEL within the OAS," adopted by the Seventh Regular Meeting of Assembly of CITEL, in which CITEL invites the OAS General Assembly to renew its commitment to the financial sustainability of CITEL; and

#### CONSIDERING:

That telecommunications and information and communication technologies (ICTs) are key enabling tools for social, economic, cultural, and environmental development and, therefore, for the implementation of the 2030 Agenda for Sustainable Development;

That CITEL is the specialized agency of the OAS for telecommunications and ICTs and, as such, effectively contributes to the implementation of the four OAS pillars and the mandates and initiatives of the Summits of the Americas, to which end it has encouraged, along with the region's political leaders, actions such as the launch of the public-private initiative 2030 ICT Alliance for the Americas, calls for greater investment in broadband infrastructure, the promotion of broadband access in the interest of social inclusion, and the Rural Women's Alliance – Empowering Rural Women Through ICTs;

That, reflecting its unique membership-based role and its ability to bring together academia, the private sector, the technical community, and government, CITEL promotes the interests of the entire Hemisphere at the World Telecommunication and Radiocommunication Assemblies and Conferences of the International Telecommunication Union (ITU) through the adoption of Inter-American proposals;

That, according to the ITU, to date one-third of the region's population does not have access to broadband connectivity, and that it is important to continue strengthening CITEL as the crucial arena for cooperation in communications and ICTs in the Americas, most particularly in its role in the debate of and reaching agreement on digital inclusion, the development of telecommunication infrastructure, radio spectrum use, and the creation of an enabling environment for investment in ICTs;

That Resolution AG/RES. 2966 (LI-O/21) "Initiatives for the expansion of telecommunications/information and communication technologies in rural, unserved and unserved areas" proposed by CITEL, has generated great interest in the Member States of the OAS and, the Secretariat of CITEL are carrying out technical support for its implementation in Ecuador and the Dominican Republic. Similarly, steps are being taken to implement it in Paraguay and in other States of the Americas;

That it is necessary to improve coverage and identify the development of models to bridge the digital divide, with CITEL making recommendations for the expansion of telecommunications/ICTs in rural areas and in unserved or underserved areas:

That CITEL has undertaken actions in coordination with the ITU, CTU, and COMTELCA to improve communications and response capabilities with a view to building resilience to disasters and emergency situations in the region; and

That, having assessed the positive results of the work it has been doing, it is necessary to guarantee the financial sustainability of CITEL in order to ensure that it is equipped with the tools required to continue with its work and to implement its 2022–2026 Strategic Plan in line with the Organization's Comprehensive Strategic Plan,

#### **RESOLVES:**

- 1. To encourage member states to intensify horizontal cooperation and the exchange of information, experiences, and best practices among them in the area of telecommunications and information and communication technologies (ICTs), with the support of the Executive Secretariat of the Inter-American Telecommunication Commission (CITEL).
- 2. To encourage member states to implement activities in their countries and in the region with the aim to advance in the strengthening of telecommunications/information and communication technologies as key drivers of sustainable development, and to invite them to participate in the various activities organized by CITEL.
- 3. To reaffirm that CITEL plays a fundamental role in facilitating and promoting digital inclusion and transformation, and the sustainable development of telecommunications/information and communication technologies (ICTs) in support of the fundamental pillars of the Organization of American States (OAS).
- 4. To request that, in the draft program-budget for 2024 for its consideration by the Committee on Administrative and Budgetary Affairs and adoption by the General Assembly, the OAS General Secretariat continue taking into account the financial needs of CITEL in keeping with Resolution CITEL/RES. 80 (VII-18), adopted at the Seventh Regular Meeting of the Assembly of CITEL, and with Resolution AG/RES. 2985 (LII-O/22), "Program-Budget of the Organization for 2022," adopted at the fifty-second regular session of the OAS General Assembly, so that the Commission can continue fulfilling its goals and mission and optimize its operation.
- 5. To request that the Secretariat of CITEL report to the OAS General Assembly, during its fifty-fourth regular session, on the implementation of this resolution, whose execution will be subject to the availability of financial resources in the program-budget of the Organization and other resources.
