**AN ACT** to amend the Fiscal Management and Accountability Act.

Enacted by the Parliament of Guyana:-

Short title.  
Cap. 73:02

1. This Act, which amends the Fiscal Management and Accountability Act, may be cited as the Fiscal Management and Accountability (Amendment) Act 2021.

Amendment of  
section 2 of the  
Principal Act.

2. Section 2 of the Principal Act is amended by inserting after the definition of “Consolidated Fund” the following definition-

“Constitutional Agency” means an agency listed in the Third Schedule to the Constitution;”.

Amendment of  
section 66 of the  
Principal Act.

2A. Section 66 of the Principal Act is amended by substituting for the words “Part IX” the word “Act”.

Amendment of the  
Principal Act.

3. The Principal Act is amended by substituting for the heading “Part XIIA”, which appears immediately after section 80, the following heading –

**“PART XIIA  
CONSTITUTIONAL AGENCIES”.**

Amendment of  
section 80A of the  
Principal Act.

4. Section 80A of the Principal Act is amended by inserting after the word “Agencies” the words “and the format for the annual report of a Constitutional Agency shall be as determined by the official in charge of the Constitutional Agency in consultation with the concerned Minister and the Minister”.

Amendment of  
section 80B of the  
Principal Act.

5. Section 80B of the Principal Act is amended as follows-

- (a) by deleting subsections (1) to (4); and
- (b) in subsection (5), by inserting after the words “Constitutional Agencies” the words “which shall be reviewed and approved

as part of the process of the determination of the national budget”.

Deletion of section 80C.

6. Section 80C of the Principal Act is deleted.

Amendment to the Schedule to the Principal Act.

7. The Schedule to the Principal Act is amended by inserting the following agencies-
