# Quality is ... something of a known standard or 'degree of excellence'



#### World Health Organisation

 Quality is "the extent to which health care services provided to individuals and patient populations improve desired health outcomes".

#### Treatment must be

- safe;
- effective;
- timely;
- efficient;
- equitable; and
- people-centred






### INTERNATIONAL GOALS AND AGREEMENT ON ETHICAL, EVIDENCE-BASED PRACTICE IN SUBSTANCE USE DISORDERS TREATMENT

### **United Nations Sustainable Development Goals 2030**

SDG Target 3.5: Global priority to strengthen the prevention and treatment of substance abuse, including narcotic drug abuse and the harmful use of alcohol.... Members States consider expanding the coverage of treatment and improving the quality of treatment systems and services

### WHY SUBSTANCE USE DISORDER TREATMENT IS IMPORTANT



- Untreated substance use disorders particularly dependence – is costly to countries – in terms of the harm to individuals, families and communities, and the economic burdens
- Substance use disorders can be successfully treated
- Substance use disorders treatment is costeffective
  - IF the treatment is of good quality
  - **IF** the treatment is tailored to individual needs
- Planned and funded quality systems are required with the involvement of all local stakeholders
- Must ensure quality not just capacity



### WHO/UNODC INTERNATIONAL STANDARDS (2020): SPECIAL POPULATIONS

### Women and Pregnant Women

Special considerations noted for a tailored approach to delivering care in a People centred way:

- Significant interpersonal relationships and family history play an integral role in the initiation of drug use.
- Stigma deters treatment entry for woman.
- Women often enter treatment for drug use disorders from a wider array of referral sources.
- Women are more likely to encounter obstacles in seeking and during treatment as a result of caregiver roles, gender expectations and socioeconomic hardships. These barriers may result in a delayed treatment entrance at a more severe stage of the disorder with additional medical and psychiatric pathology.



### WHO/UNODC INTERNATIONAL STANDARDS (2020): SPECIAL POPULATIONS

- Women are more likely to engage in help-seeking behavior and in attending treatment after admission.
- Pregnant woman may require adjustment of medication dosages.
- Woman may require women focused treatment in a safe single sex setting to obtain maximum Benefit.
- Woman may need training and support on issues such as sexual health, contraception, parenting and child care.
- Woman and children are more vulnerable to risk of domestic violence and sexual abuse, therefore a liaison with social agencies protecting children an women is helpful.
- Treatment services should be able to accommodate children to allow mothers to receive treatment.




### SYSTEM LEVEL QUALITY ASSURANCE

Are substance use disorder **Systems** designed in line with 'the International Standards' WHO/UNODC 2020.

#### **5 System Standards**

- Multiagency planning
- Needs assessment
- System plan (all key types of treatment in line treatment with WHO/UNODC 2020)
- Funding in line with plan
- System quality assurance (data, reduce stigma, uphold human rights, staff competence)

### TWO INITIATIVES TO IMPROVE QUALITY and ALIGN WITH INTERNATIONAL STANDARDS AND GUIDANCE

FIRST initiative: Program for International Quality Assurance in Treatment (PIQAT)

<u>PIQAT</u> is a QA project funded by INL, providing technical support to countries to plan a system of care for people with substance use disorders and offer services that are evidence based and in line with international standards.

It is offered by, and supported through projects with, three international organizations, namely Colombo Plan, OAS/CICAD and UNODC.

Its purpose is to assess countries' adherence to and compliance with international standards that are based on science and ethical principles and to support countries in sustaining their quality improvement efforts.

Though the approach to the quality assurance assessment is standardized, it is tailored to the interest expressed by a country; it involves an implementation approach that utilizes an agreed-to set of 13 steps to assess the system and the services in a country.

Support the country to develop or adapt the quality control mechanism: support it in various cycles of evaluation and improvement until it is sustained

Help the country establish a quality control mechanism in accordance with international standards

The country has sustainable quality control for the treatment of SUD and joins the international community to share good practices



### INTERNATIONAL CONSORTIUM ON QUALITY IN SUBSTANCE USE DISORDERS TREATMENT (ICQ)

#### Vision:

A healthier global community where quality, evidence and human rights transform approaches to treatment services for people with substance use disorders, their families and communities.

#### Mission:

ICQ provides global leadership and a hub for organizations interested in promoting and improving the quality of substance use disorders (SUD) treatment system and services to ensure the best positive outcomes for people who use alcohol and other drugs.

#### **Value proposition:**


ICQ was created to ensure that SUD services are in line with international standards for the treatment of substance use disorders through peer led mechanisms and resources and through technical assistance provided by the **Program for International Quality Assurance in Treatment (PIQAT)** and offered by Colombo Plan, OAS/CICAD and UNODC.

#### **PROMOTES QUALITY VIA**

- Peer-led QA mechanisms to recognize quality treatment in line with international standards.
- Training, mentoring and Peerled resources on quality and quality improvement.
- Technical assistance to help improve and sustain QA in countries (PIQAT) offered by Colombo Plan, OAS/CICAD and UNODC.



### THROUGH PIQATAND ICQ INITIATIVES FOR INTERESTED COUNTRIES: EMBED QUALITY & QUALITY ASSURANCE IN SUD SYSTEMS AND SERVICES

**Assessment** of a system and service against international standards.

**Partnership** with countries to do assessment based on a standardized set of steps which includes a team of local stakeholders and external experts (through Colombo Plan, OAS/CICAD and UNODC) to undertake assessment of the system and services.

Ideally embed a culture of continuous improvement in services and systems and create a **sustainable** quality system of care.



### CONCLUSIONS: STANDARDS SUPPORTED BY QA MECHANISMS HELP EMBED SUSTAINABLE, DEMONSTRABLE QUALITY IN SUD TREATMENT

#### ICQ and PIQATINITIATIVES

- BOTH Initiatives promote international standards AND sustainable ways to check fidelity or adherence to via Quality Assurance mechanisms and cycles of continuous improvement; and
- TOGETHER they provide resources, expert advice and technical support to interested organizations and countries to achieve international recognition and sustainable ways to ensure fidelity to and alignment with international standards.



### FOCUS IN CANADA AND PERSONAL REFLECTIONS

We all have strengths in our system and all have room for improvement; Canada is no exception. The issues we face and are addressing to improve quality relate to:

#### **□** Accessibility:

- Long waiting times.
- · Publicly funded and privately funded.
- Primary care: inability to access primary care.

#### **□** People centred care:

- To integrate or not integrate Mental Health and Substance Use Health.
- The patient as a member of the team.
- Tailoring our services to people served: focus on equity, diversity and inclusivity.
- ☐ Specific Competencies in Substance Use and Addiction



### FOCUS IN CANADA AND PERSONAL REFLECTION

- ☐ Siloed system of care:
  - With physical care, social services and mental health.
  - New standards of accreditation.
  - New Federal initiative focusing on standards for both MH and SUH and collaboration with primary care.
- □ System funding and accountability for 'desired health outcomes'
- ☐ Stigma towards people who use alcohol and other drugs

#### My hope

People who use drugs should have access to the same level of quality services as anyone else with a chronic health condition.
