











#### Current situation with NPS and SD

# Regulatory Measures and Early Warning Systems



# **Executive Branch**













Ministry of Health (MS), Ministry of Public Security (MSP), Ministry of Justice and Peace (MJP)

## **Judicial Branch**





Judicial Investigation Agency (OIJ) and Public Prosecution Service (MP)

Law No. 8204: Law on narcotics, psychotropic substances, drugs of unauthorized use, money laundering, related activities, and financing of terrorism (December 26, 2001)

Endorses the international conventions and agreements of the International Narcotics Control Board (INCB: green, yellow, and red lists) and allows the Drug Monitoring Board (JVD) to draw up national lists according to early detection trends, mainly as reported by the Department of Forensic Sciences (DCF) to the Costa Rican Drug Institute (ICD) and by the Ministry of Health (MS).



Law No. 10113: Law on cannabis for medicinal and therapeutic use and on hemp for food and industrial use (March 2, 2022)

Regulates the medicinal use of cannabis products and cannabinoids, as well as the use of food or industrial hemp, with particular restrictions on cannabinoid content (including delta-8-THC and delta-10-THC, but without directly mentioning, for example, HHC).



# Bill No. 23,383: Law on the control and regulation of cannabis for recreational use (before the legislature since October 5, 2022)

A third related law is in process (before the full legislature), which aims to regulate the recreational use of cannabis (no consensus has been reached yet for its approval by the legislature).



Bill No. 23,426: Law to promote the scientific analysis of psychoactive substances for the formulation of health policies for prevention and early warning (currently under consultation with the judiciary, as of February/March 2023)

Additionally, there is another effort, not coordinated by the ICD, which was presented for consultation at high levels of the judicial branch. It seeks to amend Law No. 8204 to make the DCF the laboratory that functions within the Early Warning System in Costa Rica (possibly in order to send reports to the Global SMART Programme); however, it lacks consensus in some sectors of the judiciary because of an absence of financing and resources and because it exceeds the scope and objectives of the DCF as part of the Judicial Investigation Agency (OIJ) and the services it provides to the "Public Prosecution Service (MP) and the courts according to their functions" within the judicial branch of Costa Rica (document 228-DG-2023/ Ref 374-2023, from the General Directorate of the OIJ and the Head Office of the DCF).

## **Early Warning Systems**

- Seizures made by the Ministry of Public Security (MSP) Drug Control Police (PCD) to identify the materials and issue the expert opinions used in court, after the evidence is prosecuted.
- Seizures made by the Ministry of Justice and Peace (MJP) Prison Police to identify the materials and issue the expert opinions used in court, after the evidence is prosecuted.
- Seizures made by the OIJ/MP to identify the materials and issue the expert opinions used in court.
- Monthly reports from the DCF/OIJ to the Costa Rican Drug Institute (ICD) as an autonomous institution in order to provide alerts on new substances detected or identified, and on trends involving increasing quantities or the emergence of uncommon presentations of those newly detected and identified substances.
